DESCRIPTIVE SUMMARY

This is the Affidavit of Orlo H. Maughan in support of the Motion for Leave to File Late Objection by the Magic Valley Underground Pumpers Association, Inc. and its members in the above-referenced subcase.

AFFIDAVIT

Orlo H. MUAGHAN., being first duly sworn, on his oath, states as follows:

- 1. My name is Orlo H. Maughan.
- 2. My address is Route # 5 Box 141, 900 North 450 West, Rupert, Idaho 83350.
- 3. I am the holder of water right numbers 36-02362, 36-07964A, which entitles me to pump groundwater from the Eastern Snake Plain Aquifer for irrigation purposes.
- 4. I am a member of the Magic Valley Underground Pumpers Association, Inc.
- 5. I am familiar with the Petition for Delivery Call filed by A & B Irrigation District on July 27, 1994.
- 6. I was not aware until sometime after receiving the Petition of the history of the issuance of Water License No. 20736, including the fact that the State Reclamation Engineer ruled in 1956 that the wells drilled under Permit 20736 were not entitled to a uniform priority date of September 9, 1948.


