On February 25, 1994, the Conservation Groups filed their *Amended Motion for Leave to Intervene* in the above subcases and the matter was set for hearing. The A&B Irrigation District lodged its *Memorandum in Opposition to Amended Motion for Leave to Intervene* on March 31, 1994.

On February 22, 1996, the Conservation Groups filed their *Notice of Withdrawal of Motion to Intervene and Proposed Objections*. However, the *Notice* was "contingent upon all parties bearing their own costs and fees herein." No one responded to the *Notice*.

On March 6, 1996, a hearing was convened at the SRBA Courthouse, Twin Falls, Idaho, on the *Amended Motion*. Nicholas B. Spencer appeared by telephone for IDWR. No one else appeared.

THEREFORE, IT IS ORDERED that the Conservation Groups' *Amended Motion for Leave to Intervene* is dismissed. All parties and the Conservation Groups shall bear their own costs and fees.


