

If the claim cannot be reconciled at the Initial Hearing, the court will set the subcase(s) for trial. **IF YOU INTEND TO AMEND YOUR CLAIM YOU MUST DO SO AT OR BEFORE THE INITIAL HEARING.**

Settlement documents must be filed with the court by August 18, 2017, or hearing will not be vacated.


