In our conversation you indicated that Integrow Malt LLC was bought out by Busch Agricultural Resources LLC. In order to update our records, we need documentation related to that transaction, showing that Busch Agricultural Resources LLC is the current owner of the property. I noticed that the Bonneville County website still shows Integrow Malt LLC as current owner of the place of use associated with permit 25-13978.
