On May 17, 2021, CHOBANI LLC, filed Application for Permit No. 47-17745 with the Idaho Department of Water Resources (Department). Protests were filed by BURKS TRACTOR COMPANY INC, IDAHO POWER COMPANY, and CITY OF TWIN FALLS.

On Thursday, February 3, 2022, a pre-hearing conference was held, however no resolution was reached. The parties requested that a formal hearing be held to resolve the protested matter.

Hearing Officer Peter Anderson has been assigned to preside over this contested case hearing.
