Application for permit proposes diversion of up to 3.0 cfs of ground water for industrial use at a food manufacturing plant located on the south side of Kimberly Road (US Highway 30), approximately 3.0 miles southeast of the intersection of Main Avenue and Shoshone Street in Twin Falls. Up to four new wells to be drilled on the site will serve as points of diversion. Mitigation for the proposed use will be provided by injection of the plant's advanced treated effluent into the aquifer via wells drilled on the grounds of the plant. This application proposes to appropriate trust water and will be evaluated in compliance with Section 42-203C, Idaho Code, and IDWR's Water Appropriation Rules, IDAPA 37.03.08.

Permits will be subject to all prior water rights.
