The Department of Water Resources (Department) acknowledges the receipt of correspondence changing the entity name on the above referenced water right(s). The Department has modified its records and has enclosed a computer-generated report for you.

- Water Right No. 36-16156 is still in the process of being reviewed for final licensing. You will receive a copy of the Water Right License upon completion, which will arrive under separate cover.
- You will notice that attorney Patrick D Brown has been copied on this letter because he is listed as the attorney of record on several of these water rights. The Department can remove Mr. Brown from the water right records, if necessary, upon written authorization from either your entity or Mr. Brown.
- In addition, you will note that The Prospect Co. is shown as a current owner on Water Right No(s). 36-2708, 36-7201, 36-7218 and 36-7568. This topic has been addressed in the past and the Department was made aware that it has been quite difficult to locate the necessary documents to remove them as a current owner. If you have further questions regarding this, please contact our office.

Updating the ownership record for a water right does not reconfirm the validity of the right. When processing a Notice of Change in Water Right Ownership, the Department does not review the history of water use to determine if the right has been forfeited or deliberately abandoned through five years or more of non-use. To read more about water right forfeiture, including how to protect a water right from forfeiture, please see Idaho Code §§ 42-222 and 42-223.

Please note, water right owners are required to report any change of water right ownership and any change of mailing address to the Department within 120 days of the change. Reporting forms are available from any office of the Department, or from the Department's website.
