CS PROPERTY DEVELOPMENT LLC ("CS") respectfully requests the Idaho Department of Water Resources ("IDWR") reconsider its Approval of the Amendments to IDWR Permit Nos. 63-33207 and 63-34385 dated October 30, 2020 to correct certain inconsistencies with conditions of approval inserted by IDWR. This Petition is filed by CS for the following reasons:

1. **Approval of Amendment to Permit No. 63-33207:** Condition No. 12 requires Proof of Application of water to beneficial use no sooner than October 1, 2017 and no later than October 1, 2018. This conflicts with Condition No. 1 requiring Proof of application of water to beneficial use to be submitted on or before October 1, 2023.
 - a. **Proposed Resolution:** Remove Condition No. 12.
2. **Approval of Amendment to Permit No. 63-34385:** Condition No. 10 requiring the submittal of Proof of application of water to beneficial use no sooner than 4 years and no later than 5 years from the date of approval of this right conflicts with Condition No. 1 requiring Proof of application of water to beneficial use on or before October 1, 2022. Permit 63-34385 was approved on September 22, 2014.
 - a. **Proposed Resolution:** Remove Condition No. 10.
