

# RENTAL AGREEMENT CONDITIONS OF ACCEPTANCE

- 1. The use of water under this agreement shall be subject to the provisions of Idaho Code § 42-1766.
- 2. Rental of the specified right from the bank does not, in itself, confirm the validity of the right or any elements of the water right, or improve the status of the right including the notion of resumption of use. It does not preclude the opportunity for review of the validity of this water right in any other department application process.
- 3. Use of water under this agreement does not constitute a dedication of the water to renter's place of use, and upon expiration of this agreement, the points of diversion and place of use of the water shall revert to those authorized under the water right and/or again be available to rent from the bank.
- 4. Use of water under this agreement shall not prejudice any action of the Department in its consideration of an application for transfer or permit filed by the applicant for this same use.
- 5. Renter agrees to comply with all applicable state and federal laws while using water under this agreement.
- 6. Renter agrees to hold the Board, the Director and the state of Idaho harmless from all liability on account of negligent acts of the renter while using water.
- 7. Renter acknowledges and agrees that the Director may terminate authorization for the use of a water right based on a water right's priority date.

- 8. Failure of the renter to comply with the conditions of this agreement is cause for the Director to rescind approval of the rental agreement.
- 9. The use of water for irrigation under water rights 2-2240 and 2-2431 may begin as early as March 1 and may continue to as late as November 15, provided other elements of the right are not exceeded. The use of water before April 1 and after October 31 under this remark is subordinate to all water rights having no subordinate early or late irrigation use and a priority date earlier than 06/18/2014.
- 10. This rental does not grant any right-of-way or easement across the land of another.
- 11. The rental place of use does not include federal land.
- 12. This rights on this rental, when combined with all other rights, shall provide no more than 0.02 cfs per acre nor more than 4.5 afa per acre at the field headgate for irrigation of the place of use.

# Water Modeling Requirement Information Sheet

# Information on water modeling requirements for rental requests within special administrative areas

Important information on requesting rental water within special administrative areas: Refer to the information below to determine whether the modeling of potential impacts from your rental request is necessary. Use Section 4 of the rental application to identify selected water rights. If you submit an application to rent water from within a special administrative area and water modeling is required, your rental request will be returned if water modeling is not provided.

# Water modeling may be required when an application to rent water involves one of two scenarios:

Scenario 1: The rental request proposes to divert water from a regulated water source and/or within a special administrative area AND the distance between the rental point(s) of diversion (POD) and the POD(s) for the leased water right(s) is greater than the administratively established, acceptable distance.

# Regulated water sources may areas include:

- A. Ground water resources within the modeled area of the Eastern Snake Plain Aquifer (ESPA) and tributary aquifers;
- B. Ground water within Ground Water Management Areas (GWMAs) or Critical Ground Water Areas (CGWAs);
- C. Water resources within other specified administrative areas, as established by the Idaho Water Resource Board (IWRB) or the Idaho Department of Water Resources.

The distance between any rental POD(s) and the POD(s) for a leased water right to be rented is important. On the ESPA, distance is measured in terms of model cells that cover an area of one square mile. Ground water modeling is not required if lease POD(s) and rental POD(s) are located within the same model cell or within adjacent model cells. If the lease and rental PODs are separated by more than one model cell groundwater modeling must be completed using the IDWR ESPA Transfer Tool and modeling results must be submitted with the rental application. ESPA modeling tools can be accessed and freely downloaded from IDWR's website by visiting: www.idwr.idaho.gov/WaterManagement/WaterRights/WaterRightTransfers/resources.htm.

Ground water modeling may be required within GWMAs, CGWAs or other regulated administrative areas. Applicants who desire to rent water within an established GWMA, CGWA or other regulated administrative area should consult IDWR's website before submitting their application to review the current status of administrative orders related to regulated administrative areas. Consult www.idwr.idaho.gov/WaterInformation/GroundWaterManagement/designated\_areas.htm for information on GWMAs or CGWAs, visit https://idwr.maps.arcgis.com/home/ to use mapping tools to find other regulated areas.

Applicants interested in renting water within a GWMA, CGWA or other regulated administrative areas should request water rights that have been leased into the Bank from within the same administrative area. Generally, the Bank will not permit a rental of water within a regulated administrative area if the leased water rights are not located within that same administrative area.

Scenario 2: A rental request proposes to divert water from a different but hydraulically connected water source.

# Modeling situations may include:

A. Rental requests that propose to divert surface water rights via ground water POD(s) (wells); and


B. Rental requests that propose to divert ground water from one aquifer when the right being rented authorizes the diversion of ground water from a hydraulically connected, tributary aquifer.


Rental requests that propose to divert surface water rights from ground water points of diversion may be considered if ground water modeling establishes that the surface and ground water resources are directly and immediately hydraulically connected. An acceptable hydraulic connection occurs when at least 50 percent of the total depletions from a well are detectable from the original water source within a 24 hour period. The existing (leased) POD and proposed (rental) POD must be proximate such that diversion and use of water from the proposed POD would have substantially the same effect on the hydraulically-connected source as diversion and use of water from the original POD.

Requests to rent ground water across tributary aquifer sources may be considered if ground water modeling is provided to demonstrate that two aquifers are hydraulically connected and the anticipated impacts of diverting ground water from one source

Idaho Power is creating additional floodplain around Rippee Island on the Snake River to satisfy water quality requirements as part of the relicensing effort for their Hells Canyon Complex (Brownlee, Oxbow, and Hells Canyon Dam). This floodplain enhancement includes the development of approximately 16.5 acres of new land around the existing island to reduce the surface area and increase the depth/velocity of the Snake River adjacent to Rippee Island. The development of 16.5 acres of new property will require planting of vegetation to stabilize the island and enhance wildlife habitat. Idaho Power is working with a vegetation contractor who will provide materials and labor for the vegetation effort. In order to ensure survival of the newly planted vegetation, periodic irrigation of the plantings will be required immediately following installation until plant dormancy. Idaho Power anticipates the irrigation requirements to extend into the first fall after planting. The vegetation that will be planted includes native trees and shrubs. The plantings that will occur on the island are mostly spot plantings of trees and shrubs.

Initial designs are to install temporary mainlines and laterals and sprinkle the vegetation (see sprinkler conceptual design in Attachment #2). This will require up to several portable pumps that will be periodically moved to facilitate the irrigation. The number of pumps operated simultaneously will depend on manufacturer specifications and will not exceed a maximum diversion rate of 0.33 cfs. Diversions will occur directly from the Snake River.

The contractor, after evaluating onsite conditions and river access, may choose to irrigate the vegetation with a tanker truck and hose rather than a pressurized irrigation system. This would limit the extent of the irrigation to the area immediately around each new plant and is expected to use less water than the pressurized irrigation system. A high instantaneous diversion rate will be necessary to fill the water truck in a reasonable timeframe but will not exceed an instantaneous diversion rate of 0.33 cfs (approximately 150 gpm). The tanker truck would be filled from the Snake River. The exact manner of irrigation will be left up to the discretion of the contractor in consultation with Idaho Power.

Idaho Power is seeking a two-year rental as a contingency in the event construction on Rippee Island is delayed due to flow conditions on the Snake River or other unforeseen circumstances.

**Purpose/Narrative:** An application was received from Idaho Power Company (IPCO) on January 29<sup>th</sup>, 2020, requesting a two year rental of water rights, to authorize the irrigation of 16.5 acres of land that is being reclaimed from the Snake River, adjacent Ripee Island. IPCO is dredging up soil from the Snake River, and depositing it near Rippee Island, as part of a water quality improvement project associated with the federal and state relicensing of IPCO's Hells Canyon Complex of hydropower dams.

The water quality improvement project involves both speeding up and slowing down Snake River water, to improve water quality. Where soil is dredged up from the river, deeper channels will allow for water to move more quickly around the island, which will reduce the rate at which thermal temperatures rise, while allowing for cooler water to continue further downstream where it is needed. Alternatively, native plants are being situated in the low-lying dredged soil, will help capture sediment and solids in the water, and thereby improve overall water clarity. The purpose of this irrigation rental is to help establish native plantings on the dredged soils. IDWR has approved a stream channel alteration permit for this project as well (SCA project no. S02-20103).

This rental was initially requested for two years, with the intent that that the primary irrigation work would occur in 2020, with follow up rentals in 2021, and a rental was approved in February 2020. However, due to delays in construction, in April 2020, IPCO requested that the rental be delayed until 2021. Because this was originally requested to be a two year rental, the rental will be approved for 2021 through 2022.

**Authority to File:** The application was prepared and submitted on behalf of Idaho Power by Kresta Davis-Butts. Documentation was provided indicating that Ms. Davis-Butts is a representative of Idaho Power and is able to sign on their behalf. The rental location is on lands that will be reclaimed within the Snake River which will belong to the State of Idaho. Per application item 3K, Idaho Department of Lands has consented to the irrigation rental. No concerns at this time.

**Water Right Validity/Forfeiture Evaluation:** The leased water right is in the Bank and available to be rented. No concerns about its validity.

**Injury Evaluation:** Stream Channel Alteration permit application S02-20103 has been approved by IDWR. Injury to the Snake River should be protected through adherence to the permit conditions. The place of use for the water rights being used to facilitate this rental are approximately three miles upstream of the rental location. The rental place of use is adjacent to Rippee Island, which is land belonging to the United States as part of the Deer Flats National Wildlife Refuge however, no irrigation is anticipated on federal lands. As the place of use for the leased water rights being idled, water will be left in stream to provide for this rental. No injury concerns at this time.

**Enlargement of Use:** The place of use is intended to be on new lands along the river which will receive a constant supply of Snake River water. Proportionately, water rights 2-2431 & 2-2240 authorize a diversion

volume of 146.9 af from the Snake River for irrigation of 16.5 acres. However, this rental will enforce a diversion volume limit of 74.3 af, which is calculated based on a regional field headgate standard of 4.5 afa/ac. Provided that no more than 0.34 cfs and 74.3 af are diverted for this rental, no enlargement should occur.

Local Public Interest: Staff are unaware of any local public interests that are averse to the rental.

**Beneficial Use/Conservation of Water Resources:** The rental appears consistent with the conservation of water resources in Idaho.

**Department/Watermaster Comments:** IDWR Western Region comments were requested February 24, 2020. Comments were re-requested on October 1, 2020, to reflect changes to the original request.

Water Supply Bank Evaluation: Bank staff recommend the approval of this rental through 2022.
