RE: Application for Permit 22-7624

Dear Applicant:

On December 8, 1988, you filed Application 22-7624, seeking a permit to divert water from Fox Creek for the irrigation of 347 acres in Sections 35 and 36, T04N, R45E. The application states that you held a long-term lease from the American Society for Environmental Education ("ASEE") to farm the proposed place of use. As I was recently reviewing pending application files, I discovered that ASEE no longer owns any of the land at the proposed place of use. Pursuant to Rule 40.05(e) of the Department's Water Appropriation Rules (IDAPA 37.03.08), an applicant can be required to submit copies of "deeds, leases, easements or applications for rights-of way" showing "a possessory interest in the lands necessary for all project facilities and the place of use."

An applicant has an ongoing duty to ensure that a pending application remains complete and viable. Part of that duty includes maintaining an ownership interest in the place of use described in the application.

It appears that ASEE has sold the property described in Application 22-7624 and you likely have no further interest in pursuing the application. This letter is intended to be a formal request for you to provide documents showing an ongoing possessory interest in the proposed place of use. Please provide these documents, if any exist, on or before September 30, 2020. If no documents are provided, the Department will take steps to void Application 22-7624. You can also simply withdraw the application. This can be done by stating your intent to withdraw the application in a letter to the Department. Please feel free to call me with any questions.
