The use of water before March 15 under this remark is subordinate to all water rights having no subordinated early irrigation use and a priority date earlier than the date a partial decree is entered for this right.

4. C04 Right includes accomplished change in purpose of use pursuant to Section 42-1425, Idaho Code.
5. Use of this right is combined with water from Pioneer Irrigation District.
6. E62 This right when combined with Right No. 63-10437 shall provide no more than .02 cfs per acre.
