For value received MARGARET F. RENWICK, a single woman ("Grantor"), conveys, grants, bargains, and sells to ROBERT A. YANTIS and NANCY A. YANTIS, husband and wife ("Grantee"), whose address is 2235 Middle Fork Rd., Council, ID 83612, and their successors and assigns forever, that certain real property situated in Adams County, State of Idaho, more particularly described in 'Exhibit A,' hereto.

SUBJECT TO reservations, covenants, conditions, restrictions and easements for all existing roads and utility installations all as the same appear of record or are apparent from an inspection of the property including, but not limited to, that certain lease agreement with certain terms, covenants, conditions and provisions set forth therein by and between James A. and Margaret F. Renwick and WWC Holdings Co., Inc. recorded as Instrument No. 100412 in the real property records of Adams County, Idaho; including also, discrepancies, conflicts in boundary lines, shortage in area, encroachments or any other facts which a correct survey would disclose.

This conveyance shall include any and all estate, right, title, interest, appurtenances, tenements, hereditaments, reversions, remainders, easements, rents, issues, profits, rights-of-way and water rights in anywise appertaining to the real property herein described; this deed is given in fulfillment of that certain unrecorded real estate Contract of Sale dated on or about February 11, 1999 by and between James A. and Margaret F. Yantis, and the covenants of warranty herein shall not apply to any title, interest or encumbrance arising by, through or under the purchaser in said contract, and shall not apply to any taxes, assessments or other charges levied, assessed or becoming due subsequent to the date of said contract, unless otherwise expressly excepted in writing.

The Grantor covenants to the Grantee that Grantor is the owner in fee simple of said real property; that the real property is free from all encumbrances, excepting those as may be herein set forth, and excepting those of record, and that Grantor will warrant and defend the same from all lawful claims.

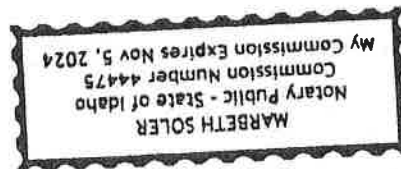

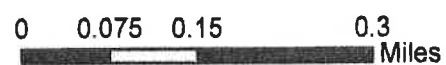

The Idaho Department of Water Resources (Western) received a Notice of Change in Water Right Ownership from you on March 30, 2020 for the above referenced water rights. The Notice could not be processed because the deed submitted with the Notice did not cover the entire place of use for the water rights, and did not name Jerry Yantis as an owner of the water rights and/or property.

On April 20, 2020, the Department requested another deed and/or additional fees to process the change in ownership as a split. As of the date of this letter, the Department has not received the required information or additional fees.

The Department is returning your Notice of Change in Water Right Ownership and the attachments. A refund of \$125 has been requested and will be mailed to Robert and Nancy Yantis under separate cover from the Idaho State Controller's Office. You may re-submit your request with the appropriate documents and fees.

Dear Interested Parties:

The Department of Water Resources (Western) acknowledges receipt of your Notice of Change in Water Right Ownership.

Our review of your Notice indicates that additional information is required before the Department can process the change. The information required is indicated below:

- _____ Evidence of Water Right Ownership: copy of Deed, Title Policy, Contract of Sale, or other legal document indicating your ownership of the property and/or water rights in question
- _____ Description of Portion of Water Right resulting from division of water right

During our review of the documentation you submitted we found discrepancies between that documentation and the legal description of the place of use for the water rights indicated in your notice. I have enclosed a copy of the water rights and a map for your reference.

The place of use for the indicated water rights includes property to the west of U.S. Highway 95 as shown on the provided map, which is not included in the legal description provided with your submitted Warranty Deed. If you do own this property, please submit a conveyance document complete with legal description to the Department showing ownership of said property. If you do not own this property, you will need to file a split ownership change for the portion of the water rights that belong to you. The fee for a split ownership change is \$100 per water right, and the \$175 fee previously submitted will be applied toward the balance.

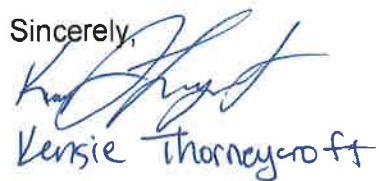
Additionally, we are unable to add Jerry Yantis as an owner for the above referenced water rights, as he is not listed on the conveyance document as an owner. If Jerry Yantis is a legal owner of the water rights, please submit evidence of his ownership.

Because the Department cannot process the Notice without proper documentation, we will hold any action on your notice pending receipt of the necessary information. If we do not receive the necessary information within 30 days we will return your notice and all attachments and your notice will not be processed.

Also, please note that permit holders are required to report any change of ownership and/or mailing address to the Department within 120 days of the change. Failure to report these changes could result in a \$100 late filing fee. Forms to assign ownership or update your address are available from any office of the Department or on the Department's website.
