I initiated a phone call to Dan Surmeier to try to get a field exam scheduled. Dan also expressed an interest in licensing the permit. He said the well pump was currently not working due to a storm that knocked out a power pole a few years ago. We discuss the way his system works. The well is close to the pond (closer than our mapping shows) and runs into the pond. There are a lot of springs along that hillside, so the well is not very deep (about 10 feet). It is the Surmeiers' intent to use this water in dry years by pumping it up the hill from the pond and then using it irrigate, letting the wastewater drain down across the acreage. He said they had never put that system in since it costs money to both run the well and pump the water up the hill.

I told Dan that it may be possible to license the permit without the pump currently working. He would need to provide some proof that the well was operating previously. He said that he recalled people being out to his place before, walking around, and thought that an exam had already taken place. I told him I would look in to that.

We would like to schedule a time to conduct a water right licensing examination of the abovereferenced permit. An examination is needed to verify the water use in order to issue a water right license.

Please be advised that you will need to operate your system under normal operating conditions during the examination.
