UPON CONSIDERATION of the *Petition for Judicial Examination, Approval and
Confirmation of Dissolution* (hereinafter "Petition") on file herein, notice having been provided
and a hearing on any objections having been scheduled and passed, and good cause appearing for
the relief requested therefor;

IT IS HEREBY ORDERED that the Petition to approve and confirm the dissolution of
Center Irrigation District (hereinafter "District") is GRANTED;

**ORDER FOR APPROVAL AND CONFIRMATION OF DISSOLUTION OF CENTER
IRRIGATION DISTRICT – Page 1**

IT IS FURTHER ORDERED that pursuant to I.C. § 43-1308, the Court confirms the proceedings sought in said Petition and orders and decrees the dissolution of the District and orders, decrees and confirms the transfer of assets, including bank accounts, water rights, ditch rights, real property and personal property, specifically including those assets described in Exhibit 6 to the Petition, to Gold Fork Irrigating Co. (hereinafter “Gold Fork”) by either deed, bill of sale or other acceptable means upon the conditions stated in the Memorandum of Understanding attached as **Exhibit 3** to the Petition and the issuance of shares in Gold Fork to the landowners of the District. The transfer of assets, deeds or bill of sale necessary to effectuate is Order shall be signed and approved by the Board of Directors listed/provided in the Petition;

IT IS FURTHER ORDERED that it appears from the Petition that there are no outstanding bonds, warrants or other in indebtedness of the District, or that the holders of any outstanding indebtedness have filed no objections to the proceedings, and therefore the Court orders District to pay and satisfy any known outstanding debts or obligations and to collect any outstanding receivables as of the date of this Order, including any delinquent assessments still owed by landowners and, pursuant to I.C. § 43-1307, any other persons having an interest in or claim against the District default is hereby entered;

IT IS FURTHER ORDERED that the lands of the District involved in this Petition for dissolution are particularly set forth in **Exhibit 1** attached hereto, and hereafter such lands shall be considered as unaffected by any of the matters done by the District while such lands were a part thereof, as the District is hereby dissolved and the landowners of the District, pursuant to the Memorandum of Understanding attached as **Exhibit 3** to the Petition shall become shareholders of Gold Fork.

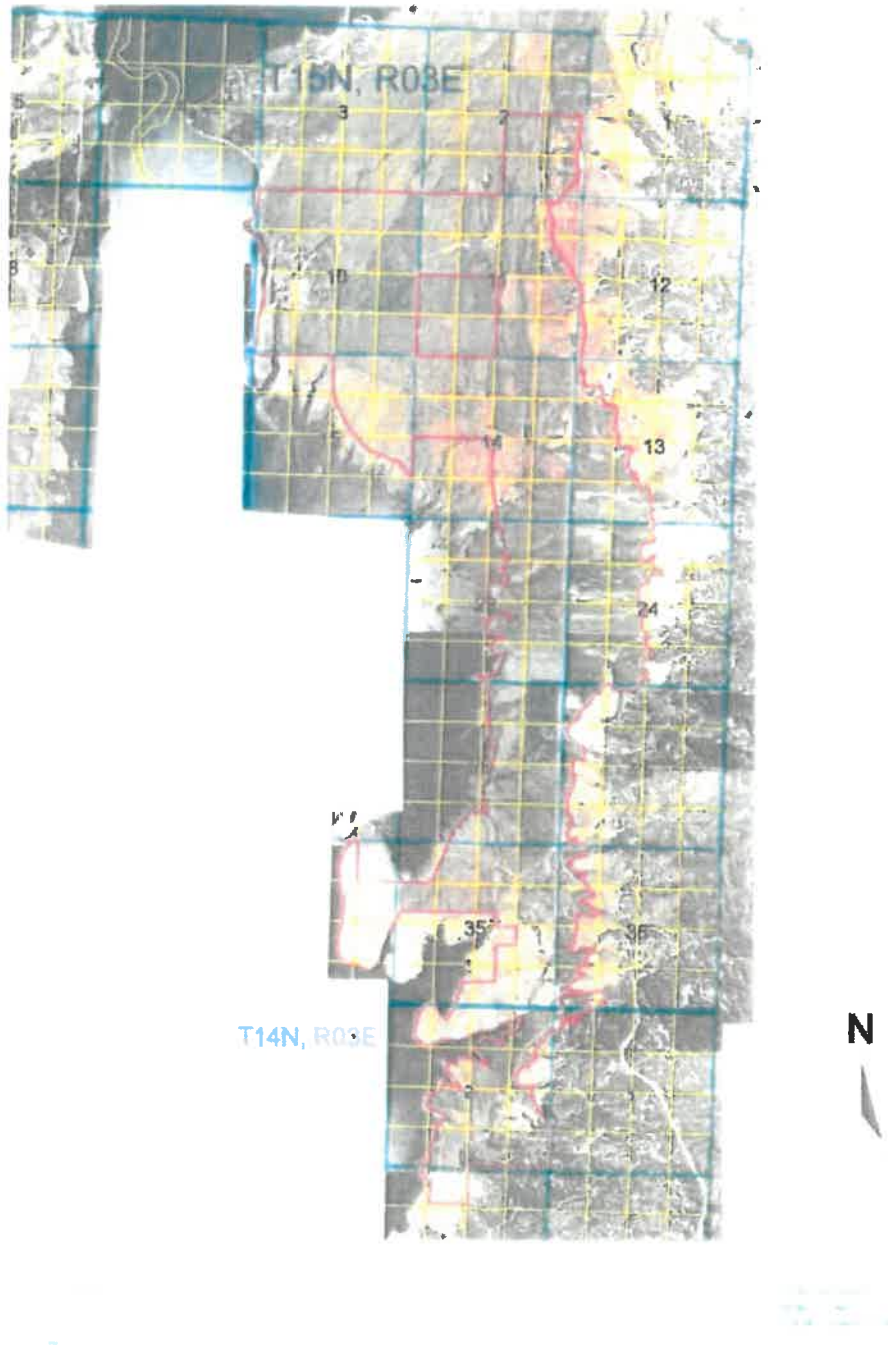
