ADOPTED AT THE ANNUAL MEETING OF THE USERS OF

WATER DISTRICT No. 11-E

Resolution B: Treasurer is to collect the budget.

Resolution C: \$3000.00 will be assessed now and the Advisory Committee along with the Chairman will determine during the year if the remaining \$2000 of the budget will need to be assessed. There will be a \$20.00 fee assessed to each share holder in the water district and the remaining budget to be apportioned according to water usage.

Resolution D: Be it resolved: That no ditch, canal company, or other water user, shall have the right to demand and receive water, and the water master shall not deliver to such person until the amount due and payable from such user, as fixed by the budget, has been paid.
