Protest is based on Idaho Code Sec. 42-222. The proposed point of diversion at NENW S29 (to lower ditch) is the same point of diversion for our water right 75-14423. Allowing additional draw from this irrigation ditch may reduce the amount of water available to those of us below the proposed irrigated land, therefore injuring our water rights. If there was in increase in the CFS to accommodate the proposed additional draw, we are concerned that the ditch may not be able to handle the additional capacity.

7. What would resolve your protest? <u>Feasibility Study to ensure irrigation ditch can handle the increased amount of water proposed.</u> In the alternative, Applicant install a second POD in Fourth of July Creek and a dedicated ditch specifically used to water the additional parcels.
