He informed me that he has already closed the ditch from the diversion down river. I believe he put a road in where the ditch was because he talked about working with Hutchinson and running some of their cows on his place.

He already has set a power pole and transformer between the house and the river and is planning on installing a pump to sprinkle irrigate the place. In so doing, this will eliminate Johnson Ditch 1 & 2 and no need for a screen at that point. We do need to furnish the screen for the pump.


