#### NOTICE TO RESUME WATER USE

Re: Water Right Nos. 3-7009, 3-7034, 3-10198, 3-10264, 67-2320, 67-4412, and 67-10975

Dear Applicant:

On April 17, 2015 the Idaho Department of Water Resources (Department) approved Applications for Extension of Time to Avoid Forfeiture for the above referenced water rights. One condition of the approvals was that diversion and use of this water must resume on or before December 31, 2020. Failure to resume use of the water and to notify the Department of the resumed use would be cause for the water to revert back to the state and again be subject to appropriation.

Idaho Code § 42-222(4)(d) requires the Department to send this notice, by certified mail, sixty days prior to the date water use must resume. Enclosed is the Resumption of Use form for your use to notify the Department of your resumption of use of the water rights. Please complete the form and return it to my attention at the above address.
