THENCE South 00°00'00" West, 188.07 feet to an iron pin;

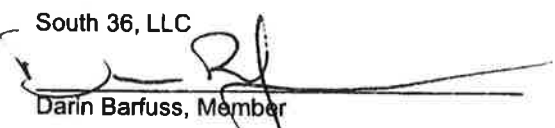

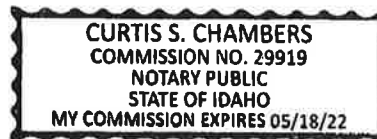
