Good afternoon Ron,

Let me preface with an apology for going back and forth on the determination of this permit. After final review of the permit, I have determined that "no additional increment of beneficial use" was developed under this permit. This is partly due to the discovery of a memo from 2/11/2010 (attached) outlining that application for permit 65-23305's intent was to account for additional storage capacity totaling the amount of this permit plus the amount already decreed by WR's 65-2923C and 65-2923E for a total of 340 af. However, as you and I have already previously discussed, I found no evidence that the capacity of Blackwell Lake is equivalent to 340 af, nor is there any documentation of how this number was calculated on behalf of Lake Reservoir Co., but rather 178 af, which existing rights already account for. Calculated reservoir capacity is equal to 37 ac surface area x avg depth 4.8 ft =178 AF. Additionally, with the dam height only being 6 ft, it is unlikely that the average depth of the reservoir is greater than an estimated 4.8 ft with all factors being considered.

Because there is no evidence to suggest that the capacity of the reservoir is greater than 178 af, and that the intent of the permit was to account for additional storage capacity and not refill, I am at this time unable to make a licensing recommendation.

If you would like to help expedite the voiding process for this permit, it would be greatly appreciated if you could please fill out and sign the attached Relinquishment of Permit form. Otherwise, if I do not hear back from you I will be issuing a 'Notice of Intent to Void' for this permit.
