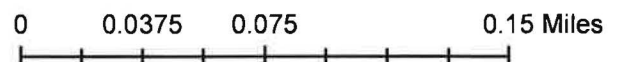
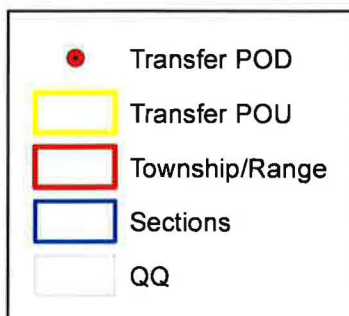
3. Prior to diversion of water under this right, the right holder shall install a lockable device, subject to the approval of the Department, in a manner that will provide the watermaster suitable control of the diversion.
4. Prior to the diversion and use of water under this approval, the right holder shall comply with all fish screening and/or fish passage requirements of the Idaho Department of Fish and Game.
5. Upon specific notification by the Department, the right holder shall install and maintain acceptable measuring device(s), including data logger(s), at the authorized point(s) of diversion, in accordance with Department specifications.
6. The quantity of water under this right for domestic use shall not exceed 13,000 gallons per day.
7. This right when combined with all other rights shall provide no more than 3.5 afa per acre at the field headgate for irrigation of the place of use.
8. Pursuant to Idaho Code § 42-1412(6), this water right is subject to such general provisions necessary for the definition of the rights or for the efficient administration of water rights as determined by the Snake River Basin Adjudication court in the final unified decree entered 08/26/2014.



EXPLANATORY INFORMATION TO ACCOMPANY A PRELIMINARY ORDER

(To be used in connection with actions when a hearing was **not** held)

(Required by Rule of Procedure 730.02)

The accompanying order or approved document is a "Preliminary Order" issued by the department pursuant to section 67-5243, Idaho Code. **It can and will become a final order without further action of the Department of Water Resources ("department") unless a party petitions for reconsideration, files an exception and brief, or requests a hearing as further described below:**

PETITION FOR RECONSIDERATION

Any party may file a petition for reconsideration of a preliminary order with the department within fourteen (14) days of the service date of this order. **Note: the petition must be received by the department within this fourteen (14) day period.** The department will act on a petition for reconsideration within twenty-one (21) days of its receipt, or the petition will be considered denied by operation of law. See Section 67-5243(3) Idaho Code.

EXCEPTIONS AND BRIEFS

Within fourteen (14) days after: (a) the service date of a preliminary order, (b) the service date of a denial of a petition for reconsideration from this preliminary order, or (c) the failure within twenty-one (21) days to grant or deny a petition for reconsideration from this preliminary order, any party may in writing support or take exceptions to any part of a preliminary order and may file briefs in support of the party's position on any issue in the proceeding with the Director. Otherwise, this preliminary order will become a final order of the agency.

REQUEST FOR HEARING

Unless a right to a hearing before the Department or the Water Resource Board is otherwise provided by statute, any person aggrieved by any final decision, determination, order or action of the Director of the Department and who has not previously been afforded an opportunity for a hearing on the matter may request a hearing pursuant to section 42-1701A(3), Idaho Code. A written petition contesting the action of the Director and requesting a hearing shall be filed within fifteen (15) days after receipt of the denial or conditional approval.

ORAL ARGUMENT

If the Director grants a petition to review the preliminary order, the Director shall allow all parties an opportunity to file briefs in support of or taking exceptions to the preliminary order and may schedule oral argument in the matter before issuing a final order. If oral arguments are to be heard, the Director will within a reasonable time period notify each party of the place, date and hour for the argument of the case. Unless the Director orders otherwise, all oral arguments will be heard in Boise, Idaho.

CERTIFICATE OF SERVICE

All exceptions, briefs, requests for oral argument and any other matters filed with the Director in connection with the preliminary order shall be served on all other parties to the proceedings in accordance with IDAPA Rules 37.01.01302 and 37.01.01303 (Rules of Procedure 302 and 303).

FINAL ORDER

The Director will issue a final order within fifty-six (56) days of receipt of the written briefs, oral argument or response to briefs, whichever is later, unless waived by the parties or for good cause shown. The Director may remand the matter for further evidentiary hearings if further factual development of the record is necessary before issuing a final order. The department will serve a copy of the final order on all parties of record.

Section 67-5246(5), Idaho Code, provides as follows:

Unless a different date is stated in a final order, the order is effective fourteen (14) days after its service date if a party has not filed a petition for reconsideration. If a party has filed a petition for reconsideration with the agency head, the final order becomes effective when:

- (a) The petition for reconsideration is disposed of; or
- (b) The petition is deemed denied because the agency head did not dispose of the petition within twenty-one (21) days.

APPEAL OF FINAL ORDER TO DISTRICT COURT

Pursuant to sections 67-5270 and 67-5272, Idaho Code, if this preliminary order becomes final, any party aggrieved by the final order or orders previously issued in this case may appeal the final order and all previously issued orders in this case to district court by filing a petition in the district court of the county in which:

- i. A hearing was held,
- ii. The final agency action was taken,
- iii. The party seeking review of the order resides, or
- iv. The real property or personal property that was the subject of the agency action is located.

The appeal must be filed within twenty-eight (28) days of this preliminary order becoming final. See section 67-5273, Idaho Code. The filing of an appeal to district court does not itself stay the effectiveness or enforcement of the order under appeal.

Good afternoon! I received a call from Cindy Yenter this morning about this transfer and I wanted to let you know what we discussed. She wanted to know if we had received any written responses to your letter to the other shared-ditch users. I told her to my knowledge we had not, but last I spoke with you about it, it was before the deadline to respond. She reiterated that she had met with most of the shared-ditch users after your letter was received by at least one of the users to discuss the transfer proposal and no one voiced any concerns. Also, she wanted to let us know that the transfer applicant can not pump all of their water right from the new POD pump due to the size of the pump. The transfer applicant still plans to divert some of their water right from the shared ditch, which will help other users with conveyance of their water rights in the shared ditch. Cindy also mentioned the guy at the very bottom of the shared ditch is getting some water now, she's not sure how much water, but he is getting some.

I believe Cindy had the applicant in her office so she was more or less after a "status update". I told her that you are out this week, so we won't likely see any movement on this application until you are back in the office.

Dear Sharon and Marcia,

Upon further review of Transfer 83265, members of the Department of Water Resources (Department) have raised concerns over the potential of conveyance loss issues within the shared ditch if the entire 0.12 cfs associated with water right (WR) No. 75-4016C were no longer diverted through the ditch. Cindy Yenter with the Department's Salmon office indicated there is currently very minimal flow authorized through the ditch due to others rights having already been transferred to other points of diversion, and how, if none of the 0.12 cfs associated with WR 75-4016C were diverted through the ditch, there may not be enough flow to supply those rights still utilizing the ditch.

To alleviate this concern, I am sending comment letters to the other right holders still utilizing the ditch to inform them of the potential removal of flow and allowing them 14 days to respond with any concerns. If no responses are received after the 14 days, then Department managers will feel confident in approving Transfer 83265 as proposed.

Good catch Scott on the POU shift. All 6 rights on that common ditch have POD issues likely the result of the same shift; I was focused on that. 4016C and 4015 are too far up the creek, 4016A is in NESE and I think so was 4016D before the POD was transferred to a pump on the property. 14271 and 10943 are in the correct spatial location but have decreed pods in NWSW Sec 7. It's like someone was shooting darts. All rights are associated with the one ditch.

The biggest potential for injury here is related to removing diverted flow from the ditch. There is only a total of 0.36 in the ditch after the 4016D transfer. 0.12 cfs of that is 4016C, and another 0.12 cfs is 4015 at the bottom. With 4016C out that leaves 0.24, and 4015 can also use 2 lower diversions and consequently should not be using the upper ditch at the same time. Without 4015, Only 0.12 remains in the ditch for the upper users who may not be able to get water down the ditch that far. Daniels 4016A is the only one who may be using the ditch if this transfer is approved, and he has a div rate of 0.04. In August of 2018 I estimated diversion in the ditch at 0.47 cfs, and it was barely making it down to Berg-Jones. I don't know that this is cause for denial, just something to be aware of.

There was plenty of flow in Spring Creek, even in August. Sufficiency of flow is not an issue. This is just a classic example of a system with multiple small rights that have to travel too far. I expect other owners to eventually transfer to pumps, as all have creek frontage.

WD Flag = NWD

Measurement of the pump will not be required (<5 ac) but measurement of the ditch is required by USFS easement and will also be required under 170 expansion.
