Hi Eric,

I was out yesterday morning at Hagerman Wings with John Shaw, Frank Erwin, and others looking at measuring devices and other items of intrest. Frank wanted to make sure the correct measurement is in place for when we need to licence the water rights. John Shaw may be contacting you also but he asked that I talk to you about what we observed.

Permits 36-17069 and 36-17116 have requirements for installing a measuring device. Currently neither permit is being measured by an industry standard open channel device. I recognize there are some difficulties for measurement and we can discuss any questions or thoughts you might have. If you chose to use a non-standard measureing device I would ask that you submit a variance request for the device (https://idwr.idaho.gov/files/water-measurement/Measuring-Devices-Minimum-Acceptable-Standards.pdf.

Water rights 36-98, 36-15467, and 2-10338 have a condition that requires a specific 121 acres to be identified for irrigation. Currently the departments records show a 202 acre shape in GIS. I looked at past documents to see if we had missed updating it but could not find that a 121 acre shape had ever been submitted. We ask that you work with Mr. Shaw to provide the Department with a shape file of the 121 acres irrigated under these water rights.
