


Dear Applicant

On April 10, 2020, the Department received an Assignment of Application for Permit for 63-31986, 63-34281 & 63-34801. After reviewing the document and the pending applications for permit, the following information is required to complete processing:

1. 63-31986 is a domestic and stockwater right that was decreed 2/16/2007. An ownership change form is needed to place the right in your name and must include a conveyance document, map and fee. I have included an ownership change form and instructions to move this right into your name.
2. 63-34281 is an active permit since 3/30/2017. An Assignment of Permit form is the correct way to transfer permit ownership. This action requires a \$25 fee. 63-34801 is an active application that has not yet been signed to permit. It is clear what the intent of the Assignment of Application for Permit was intended to achieve. We can place 63-34281 and 34801 in the name of Devon McDonald but not until the required fee of \$25 is received.
3. Application for Permit 63-34801 proposes irrigation use of 25.0 acres. The map attached to the application outlines eight quarter-quarters totaling 320 acres. A more accurate outline of the proposed irrigation is needed to accurately describe the use. Please provide a detailed map outlining the specific 25.0 acre shape.
4. The three right together propose twelve new well locations and one existing well. The Amendment of Permit form for 63-34281 states "Add additional points of diversion for drilling flexibility. Applicant proposes diversion from up to three new wells and one existing well." Please confirm the total number of wells expected to be drilled for all three rights.

Please submit the requested information for the applications to be processed. The application will be voided without a timely written reply within the next thirty (30) days. IDWR forms and other information are available on the Internet at www.idwr.idaho.gov. Please contact me at 208-334-2190 to discuss the information requested by this letter. SUBJECT: Assignment and Amendment of Permit

Devon McDonald visited Western Region today to clean up some processing issues. On April 10, 2020, the Department received an Assignment of Application for Permit form listing three water right numbers. **63-31986** is an active domestic and stockwater right that was decreed in 2007. An ownership change form was filled out and submitted today to place the right in Devon's name. **63-34281** is an active permit and **63-34801** is an active application for permit. While the assignment form received back in April is not the appropriate form to change the name of a permit, it is clear what the intent of the owners was by completing the submitted paperwork. There is no fee to assign an application for permit and Devon paid \$25 (W048462) to assign the permit into his name.

Application for Permit 63-34801 was amended to remove the irrigation component from the application. The irrigation use identified in the application is a part of Avimor development and is not related to his project.

Devon clarified that while there are 13 wells identified on the rights for flexibility, he only intends to develop up to four wells; three new and one existing well.
