

Hi Lisa,

I just wanted to follow up my call with an email as I am heading out of the office for the day.

## #5 - Proposed use

IDWR uses 0.02 cfs/acre for irrigation. So you can leave the 0.02, but clarify that it is cfs.

<u>Action:</u> If you can either write or circle the "cfs" on the Application for permit that will clear things up.

## #6 - Total Quantity

Since IDWR uses 0.02 cfs/acre for irrigation, this is where you state the total amount that will be diverted. (You will have 0.02 cfs on #5 and 1.8 cfs on #6)

<u>Action:</u> Write 1.8 in the blank for cfs and cross out 0.2 acre-feet. (The acre feet will be determined at a later date by the Department.)

#### Fee

I misread my note for the fee and the amount for the transfer is \$500 not \$660. So \$450 is left due for that. The application for permit is \$290. \$190 is left due for it.

The total for both of them (if you would like to submit one lump sum) is \$640. (Not \$800 as stated in the letter. I will correct it on my end.)

When you send the payment in, please include a small note that states \$450 is for the transfer application and \$190 is for the application for permit. This will make it easier for our staff to keep track of.

<u>Action:</u> Pay \$640 for transfer and application for permit. Write small note that states \$450 is for the transfer application and \$190 is for the application for permit.

I will be in the office Monday at 8 am in case you have any other questions. I've also included a copy of your application for transfer for your reference.

## Dear Applicant:

This office received your Application for Permit and Application for Transfer on May 18, 2020. The applications cannot be accepted into the records of the Idaho Department of Water Resources (IDWR) until the following items are addressed:

## • #5 – Proposed Use

- o Please clarify if 0.02 is cfs or af
  - Irrigation is considered a rate and is 0.02 cfs/acre
- o Season of Use: from 3/15 to 10/31

## • #6 - Total Quantity

- o The application for permit listed 0.02 af per year, but irrigation is determined using 0.02 cfs/acre rate. If the place of use (POU) is 91.2 acres (91.2 acres was determined using the original map attached to the application), then the cfs will be 1.82 cfs.
  - $0.02 \text{ cfs/acre} \times 91.2 \text{ acres} = 1.824 \text{ cfs} = 1.82 \text{ cfs}$
- Volume (af) is generally reserved for ponds/storage water on applications.

## • #9 – Place of Use

- o For irrigation use, please indicate the number of acres in the table on the application.
  - A map has been included that was generated using the original POU submitted. The numbers of acres in each QQ is listed. 38 acres in NWSW, 13 acres in SWNW, 1.2 acres in NENW, etc. Use this information to complete the table if this POU on the map is correct.
  - For the 38 acres in NWSW, you will find the smaller NW under the larger SW and write 38 in the space. This indicates 38 acres in the NW ¼ of the SW ¼. You will write the number of acres in the NENW, SWNW, SENW, NWSW, and NESW QQs.
- o Total number of acres to be irrigated: <u>91.2 acres</u> (if irrigating the whole area within POU)

## The Fee

The Application for Permit only listed 0.02 af which is likely incorrect. If the POU is 91.2 acres, then 1.82 cfs.is used to determine the correct fee. If the POU is incorrect,

determine tyotal number of acres and multiply it b 02 cfs/acre. This will give the correct cfs to pase the fee on.

- $0.02 \text{ cfs/acre} \times 91.2 \text{ acres} = 1.824 \text{ cfs} = 1.82 \text{ cfs}$  **OR**
- $0.02 \text{ cfs/acre} \times \# \text{ total acres} = \text{total cfs}$
- o The Application for Transfer lists 0.63 cfs and 269.9 af and \$50 was paid. \$50 is only used if there is no physical change on an application according to Idaho Code §42-221.O.8. There is a physical change in POD location so 269.9 af was used to determine the fee.
- O Using the fee schedule for each application, the following amounts were determined due in order to continue processing your applications:

If IDWR does not receive your written response within thirty (30) days, a refund will be issued for both filings.
