Notice of Application for Transfer 84343

On August 31, 2020, Randy and Jill Wanner filed Application for Transfer 84343, proposing to change the points of diversion and place of use for the following water rights:

These three water rights, in combination, currently authorize the irrigation of 152 acres. You are receiving this notice because all or a portion of your property lies within the current 152-acre irrigation place of use for the water rights. Application 84343 proposes to consolidate water rights 13-227, 13-314 and 13-2161 onto a 125-acre place of use located entirely on property owned by Randy and Jill Wanner. The transfer would have the effect of moving the three water rights off of your property. According to the Wanners, your property does not have access to the unnamed drain, Worm Creek, or the small reservoir on Worm Creek. The three water rights described above are currently in the name of Ervin and Neal Van Orden. Application 84343 proposes to update the ownership of the three rights to be in the name of Randy and Jill Wanner. Even though the current 152-acre place of use for the water rights includes all or a portion of your property, you have never taken any steps to update the ownership records for the rights.

If you believe that you own a portion of the water rights described above, please file a Notice of Change in Water Right Ownership on or before October 5, 2020. You may also file a protest against Application 84343. Any protest against the application must be filed on or before October 5, 2020. The ownership change form, the protest form, and instructions for completing the forms can be found on our website (idwr.idaho.gov). Please feel free to call if you have trouble finding the forms. If you do not file an ownership change or protest by October 5, 2020, I will assume that you do not assert an ownership interest in the three water rights.
