On August 1, 2019, the Idaho Department of Water Resources ("Department") approved Application for Transfer No. 83356 ("Transfer") in the name of Falls Irrigation District. The Transfer approval authorized a change to Water Rights 29-2341 and 29-11169. The Transfer included the following condition of approval:

The right holder shall accomplish the change authorized by this transfer within one year of the date of this approval.

On July 28, 2020, the right holder notified the Department that the Transfer has not yet been accomplished and requested an extension of time to complete the Transfer.

The right holder has shown reasonable cause for the delay.

IT IS, THEREFORE, HEREBY ORDERED that the right holder of Transfer No. 83356 is granted an extension to August 1, 2024 in which to accomplish the transfer.

IT IS FURTHER HEREBY ORDERED that this extension does not stay the accumulation of the five-year period associated with forfeiture of a water right for non-use.
