- 1. This right is limited to the irrigation of 78 acres within the authorized place of use in a single irrigation season.
- 2. This right when combined with all other rights shall provide no more than 0.02 cfs per acre nor exceed a combined annual maximum diversion volume of 351 af at the field headgate for the place of use.
- 3. This right when combined with all other rights shall provide no more than 4.5 afa per acre at the field headgate for irrigation of the place of use.

The right holder may divert ground water under this right to irrigate land with appurtenant surface water rights when the surface water supply is not reasonably sufficient to irrigate the place of use for this water right or is not available due to drought, curtailment by priority, or the seasonal startup and shutoff or maintenance schedule for canal company deliveries. The right holder shall not divert ground water for irrigation purposes under this right if use of the surface water supply is intentionally discontinued or reduced (for example abandoned, forfeited, sold, disallowed by court decree, or leased to the Water Supply Bank), or is not deliverable due to non-payment of annual assessments, without an approved transfer pursuant to Idaho Code § 42-222 or other Department approval.
- 6. The right holder shall accomplish the change authorized by this transfer within one year of the date of this approval.
- 7. Failure of the right holder to comply with the conditions of this transfer is cause for the Director to rescind approval of the transfer.
- 8. Pursuant to Idaho Code § 42-1412(6), this water right is subject to such general provisions necessary for the definition of the rights or for the efficient administration of water rights as determined by the Snake River Basin Adjudication court in the final unified decree entered 08/26/2014.



EXPLANATORY INFORMATION TO ACCOMPANY A PRELIMINARY ORDER

(To be used in connection with actions when a hearing was **not** held)

(Required by Rule of Procedure 730.02)

The accompanying order or approved document is a "Preliminary Order" issued by the department pursuant to section 67-5243, Idaho Code. It can and will become a final order without further action of the Department of Water Resources ("department") unless a party petitions for reconsideration, files an exception and brief, or requests a hearing as further described below:

PETITION FOR RECONSIDERATION

Any party may file a petition for reconsideration of a preliminary order with the department within fourteen (14) days of the service date of this order. Note: the petition must be <u>received</u> by the department within this fourteen (14) day period. The department will act on a petition for reconsideration within twenty-one (21) days of its receipt, or the petition will be considered denied by operation of law. See Section 67-5243(3) Idaho Code.

EXCEPTIONS AND BRIEFS

Within fourteen (14) days after: (a) the service date of a preliminary order, (b) the service date of a denial of a petition for reconsideration from this preliminary order, or (c) the failure within twenty-one (21) days to grant or deny a petition for reconsideration from this preliminary order, any party may in writing support or take exceptions to any part of a preliminary order and may file briefs in support of the party's position on any issue in the proceeding with the Director. Otherwise, this preliminary order will become a final order of the agency.

REQUEST FOR HEARING

Unless a right to a hearing before the Department or the Water Resource Board is otherwise provided by statute, any person aggrieved by any final decision, determination, order or action of the Director of the Department and who has not previously been afforded an opportunity for a hearing on the matter may request a hearing pursuant to section 42-1701A(3), Idaho Code. A written petition contesting the action of the Director and requesting a hearing shall be filed within fifteen (15) days after receipt of the denial or conditional approval.

ORAL ARGUMENT

If the Director grants a petition to review the preliminary order, the Director shall allow all parties an opportunity to file briefs in support of or taking exceptions to the preliminary order and may schedule oral argument in the matter before issuing a final order. If oral arguments are to be heard, the Director will within a reasonable time period notify each party of the place, date and hour for the argument of the case. Unless the Director orders otherwise, all oral arguments will be heard in Boise, Idaho.

CERTIFICATE OF SERVICE

All exceptions, briefs, requests for oral argument and any other matters filed with the Director in connection with the preliminary order shall be served on all other parties to the proceedings in accordance with IDAPA Rules 37.01.01302 and 37.01.01303 (Rules of Procedure 302 and 303).

FINAL ORDER

The Director will issue a final order within fifty-six (56) days of receipt of the written briefs, oral argument or response to briefs, whichever is later, unless waived by the parties or for good cause shown. The Director may remand the matter for further evidentiary hearings if further factual development of the record is necessary before issuing a final order. The department will serve a copy of the final order on all parties of record.

Section 67-5246(5), Idaho Code, provides as follows:

Unless a different date is stated in a final order, the order is effective fourteen (14) days after its service date if a party has not filed a petition for reconsideration. If a party has filed a petition for reconsideration with the agency head, the final order becomes effective when:

- (a) The petition for reconsideration is disposed of; or
- (b) The petition is deemed denied because the agency head did not dispose of the petition within twenty-one (21) days.

APPEAL OF FINAL ORDER TO DISTRICT COURT

Pursuant to sections 67-5270 and 67-5272, Idaho Code, if this preliminary order becomes final, any party aggrieved by the final order or orders previously issued in this case may appeal the final order and all previously issued orders in this case to district court by filing a petition in the district court of the county in which:

- i. A hearing was held,
- ii. The final agency action was taken,
- iii. The party seeking review of the order resides, or
- iv. The real property or personal property that was the subject of the agency action is located.

The appeal must be filed within twenty-eight (28) days of this preliminary order becoming final. See section 67-5273, Idaho Code. The filing of an appeal to district court does not itself stay the effectiveness or enforcement of the order under appeal.

Evaluation of Application

Transfer 84184 proposes a 116-acre permissible place of use (ppu) to include the entire area of the planned residential subdivision. The rigt involved in transfer 84184 (water right 63-22189) will be used in combination with surface water from Wilder Irrigation District and Nampa & Meridian Irrigation District. Actual irrigation will not exceed the decreed 78 acres, 1.56 cfs, and 351 acre-feet.

The site is located in Canyon Country, about 1 mile east of the northern part of Lake Lowell and about 3.5 miles south west of I-84.

Summary of Information Submitted

Authority to File:

RJS Investments has full authority to file transfer 84184.

Transer 84184 was filed in the name of RSJ Investments and was signed by Richard Huff. Department records verify RSJ Investments is the most current owner of water right 63-22189. Idaho Secretary of State Records indicate J Richard Huff is a current registerd agent of RSJ Investments.

The land within the proposed ppu is owned in part by RSJ Investments and in part by Lone Star Land LLC. With transfer 84184, RSJ Investments enclosed a letter from Lone Star Land signed by John Conter authorizing RSJ Investments to transfer the place of use (POU) of water right 63-22189 within Lone Star Land's parcel. Idaho Secretary of State Records indicate John Conter is a registered agent of Lone Star Land LLC.

Water Right Validity:

The partial decree for water rights no. was issued on 04/29/2009. The right is presumed to be valid since beneficial use has occurred within the last five years. Beneficial use confirmed by the Department's aerial imagery.

Injury to Other Water Rights:

Transfer 84184 will not injur other water rights. The transfer proposes no point of diversion changes or additions. The transfer may improve local groundwater availability. The proposed ppu will increase the applicant's access to surface water irrigation, decreasing their current need for supplementary ground water from water right 63-22189.

Enlargement of Use:

Enlargement concens must be addressed since transfer 84184 proposes to extend the POU boundary through the previously described ppu. The Department does not expect the transfer to result in enlargement of water right 63-22189. Upon approval, the water right will be conditioned to limit actual irrigation to 78 acres within the 116-acre ppu. Furthermore, water right 63-22189 will remain supplementary to Wilder Irrigation and Nampa & Meridian Irrigation surface water.

Transfer proposes no changes in diversion rate, annual volume, nature or period of use.

Local Public Interest:

This transfer proposes a change consistent with the local public interest.

Upon advertisement, letters requesting comment were sent to the water master of Water District 63, Nampa & Meridian Irrigation District, Wilder Irrigation District, and Lone Star Land LLC. The Department received comment only from Nampa & Meridian Irrigation ensuring the proposed transfer will not effect Nampa & Meridian Irrigation District's interests so long as the Department conditions water right 63-22189 to be "... used in combination with surface water."

Lack of comment from the other aforementioned enties imples the transfer proposal will not interfere with any entity's interests.

Beneficial Use/Conservation of Water Resources:

The application proposes beneficial use consistent with conservation of water resources in Idaho.

Water Right Overlap

Overlap was not considered as RSJ Investment does not own other irrigation rigts within the intended ppu.

The application is consistent with criteria of I. C. § 42-222 and should be processed.

Assuming protests are not filed and/or other information does not contradict the above analysis, the application can be approved as reflected by the draft approval.
