Applicant, David L. Udy ("Udy") and protestant Idaho Department of Fish and Game ("IDFG") by and through their undersigned representative and/or counsel of record, and pursuant to IDAPA 37.01.01.204, 557 and .612, hereby stipulate to a settlement of IDFG's protest in the above-entitled matter, the terms and conditions of which are set forth herein.

The parties agree that the following condition ("Condition") should be included in any approvals of Transfer Application 82751 ("Transfer") which condition was set forth in an email from the hearing officer on August 7, 2020:

Condition 1: This right is limited to the irrigation of a specific 72 acres within the 132 acre place of use authorized by this right in a single irrigation season. The specific 72 acres to be irrigated by the right holder are shown in the electronic shape file associated with this right in the geographic information system component of the water rights database maintained by the department. Before changing the 72 acres to be irrigated within the 132 acre place of use, the right holder shall submit a new land list and representative electronic shape file or map to the Department prior to the irrigation season in which the change will occur.

The parties further agree that the specific 72 acres to be irrigated under the Transfer are depicted on the map attached to the email sent by the hearing officer on August 7, 2020, and further attached hereto as Exhibit A.


The parties move the Department, pursuant to IDAPA 37.01.01.557, .612 for an order ("Order") approving the Condition set forth herein, or substantially similar conditions, and confirming that they will be included by the Department in any approvals of the Application and confirming the attached map depicting the specific 72 acres to be irrigated.

IDFG's protest to the Transfer shall be deemed withdrawn upon the issuance of a Final Order stating that the Condition and map are approved and shall be made a part of the approval of the Transfer. Provided that the Transfer is not subsequently amended from its current form, except as may be required by the Department to continue processing, the withdrawal of IDFG's protest shall be with prejudice.


