

Hello Mr. Maxey,

Thank you for your letter of 08/19/2020, regarding the application for permit from Larry and Robin Derbes. In response to the unacceptable application issue, a complete application package was mailed to the IDWR Northern Region office to correct this situation.

Regarding the potential that the spring for which Mr. and Mrs. Derbes have submitted an application for permit may already be one of the sources of water to be used by Permit 96-09587, we have researched the situation and offer the following information for your review and consideration:

- 1. The application for permit that resulted in Permit 96-09587 was based on easements that date back to 1947.
- 2. The property immediately north of Mr. & Mrs. Derbes' current property (see attached document Exhibit A, the Warranty Deed by Alliance Title & Escrow Corp. Order No.: 352405 please note that Mr. & Mrs. Derbes previously owned this property to the north of their current property, which is why their name appears on the deed) is subject to an easement that aligns with one of the easements included in the application for permit that resulted in Permit 96-09587 (see Item 10 on page 4 of the Warranty Deed). This property contains a spring that has a POD conveying water via piping to the east, which is consistent with the described proposed use in the application for permit that resulted in Permit 96-09587.
- 3. The Warranty Deed for the property currently owned by Mr. & Mrs. Derbes, which contains the spring for which they have submitted an application for permit, does not list any easements for a spring nor any other water sources or methods of water conveyance (see attached document Exhibit B, the Warranty Deed by Title One, Order Number: 20363566).
- 4. The property currently owned by Mr. & Mrs. Derbes does not have a POD at the spring for which they have submitted an application for permit. As such, there is no evidence that it is being put to beneficial use.

Based on the above facts, it appears that the map provided as part of the application for permit that resulted in Permit 96-09587 inaccurately depicted the POD locations in NW1/4SE1/4SW1/4, Sec. 26, Twp. 58N, Rge. 02W, when the actual locations appear to be approximately 500 feet to the north in SE1/4NE1/4SW1/4, Sec. 26, Twp. 58N, Rge. 02. As such, we request that the actual location of the springs and PODs associated with Permit 96-09587 be verified to determine if they are in fact different from the spring on Mr. & Mrs. Derbes' property for which they have submitted an application for permit.

We are willing to assist the IDWR with documenting the actual location of each spring and POD in question by collecting and providing GPS coordinates.

Mr. & Mrs. Derbes would like to move forward with the application for permit they have submitted if the IDWR confirms that the spring on their property is not already being put to beneficial use by another party.
