Dear Applicant:

The Department of Water Resources ("Department") received applications for Extensions of Time to Avoid Forfeiture ("applications") for water rights 2-2172, 63-3142, and 63-7083. Ryan Vander Stelt signed the applications, but I am unable to confirm that Mr. Vander Stelt has authority to sign on behalf of these rights. The website for Idaho's Secretary of State lists Lawrence Vander Stelt as the registered agent for your organization, and other documentation of authority was not provided. In addition, Dry Lake Dairy LLC is not the owner of record for water right 2-2172.

In item 3 of the applications, the Department states that authority to sign on behalf of the right holder is required. The Department cannot take action if documentation has not been provided. Because of the statutes regarding ownership, the Department is required to honor the owner of record for each right. Idaho code requires that all persons owning or claiming ownership of a water right are required to provide notice to the Department of any change in ownership within 120 days of the change. If the ownership has changed for 2-2172, I have included a Notice of Change in Ownership form for your convenience.

In order to provide you time to submit the required information, I am placing these applications on a 30-day hold for processing. Within 30 days, please submit the appropriate documentation to establish authority to sign on behalf of the water right holders. If the Department has not received a response from you within 30 days, the Department may seek to void the applications.
