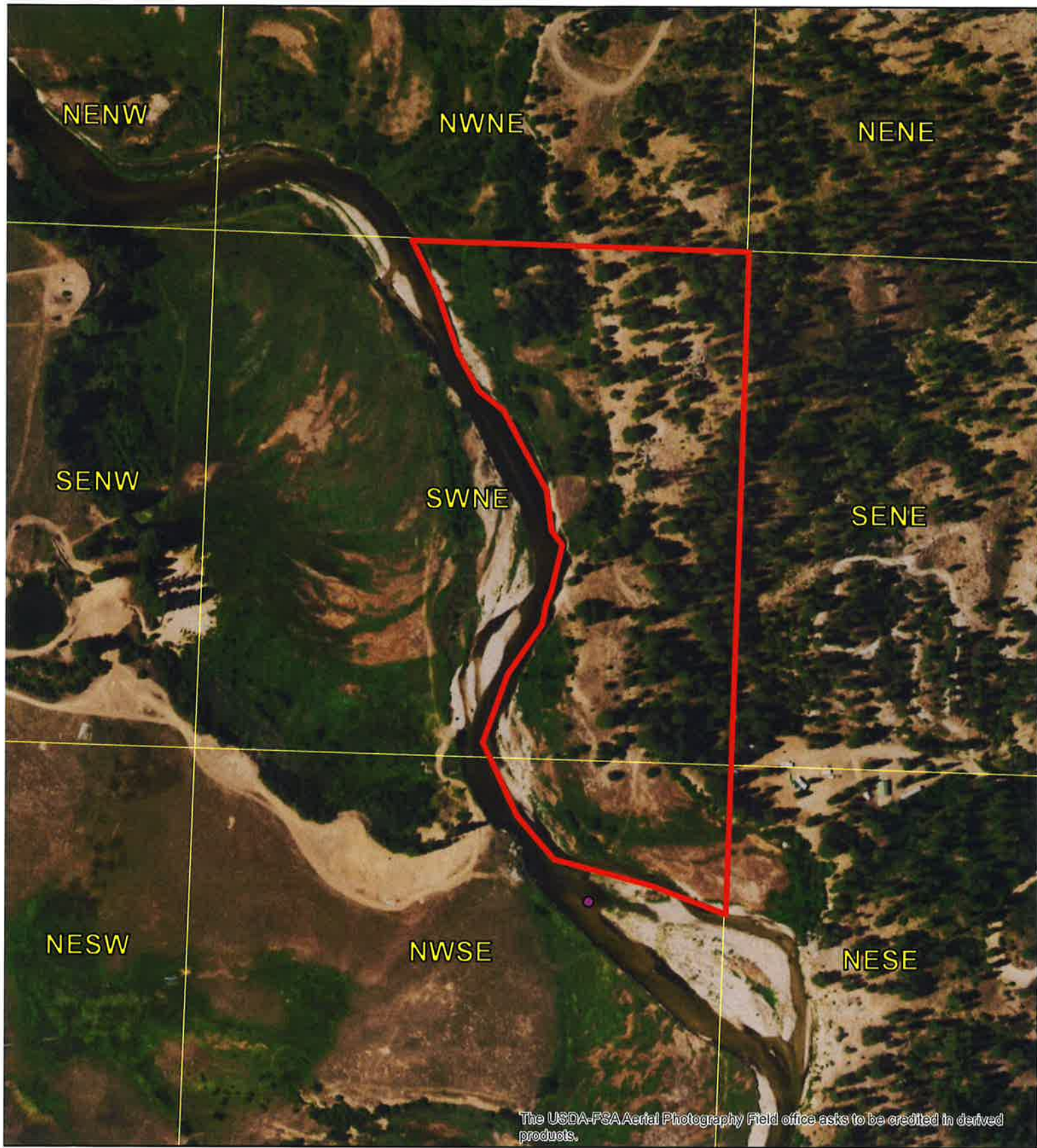

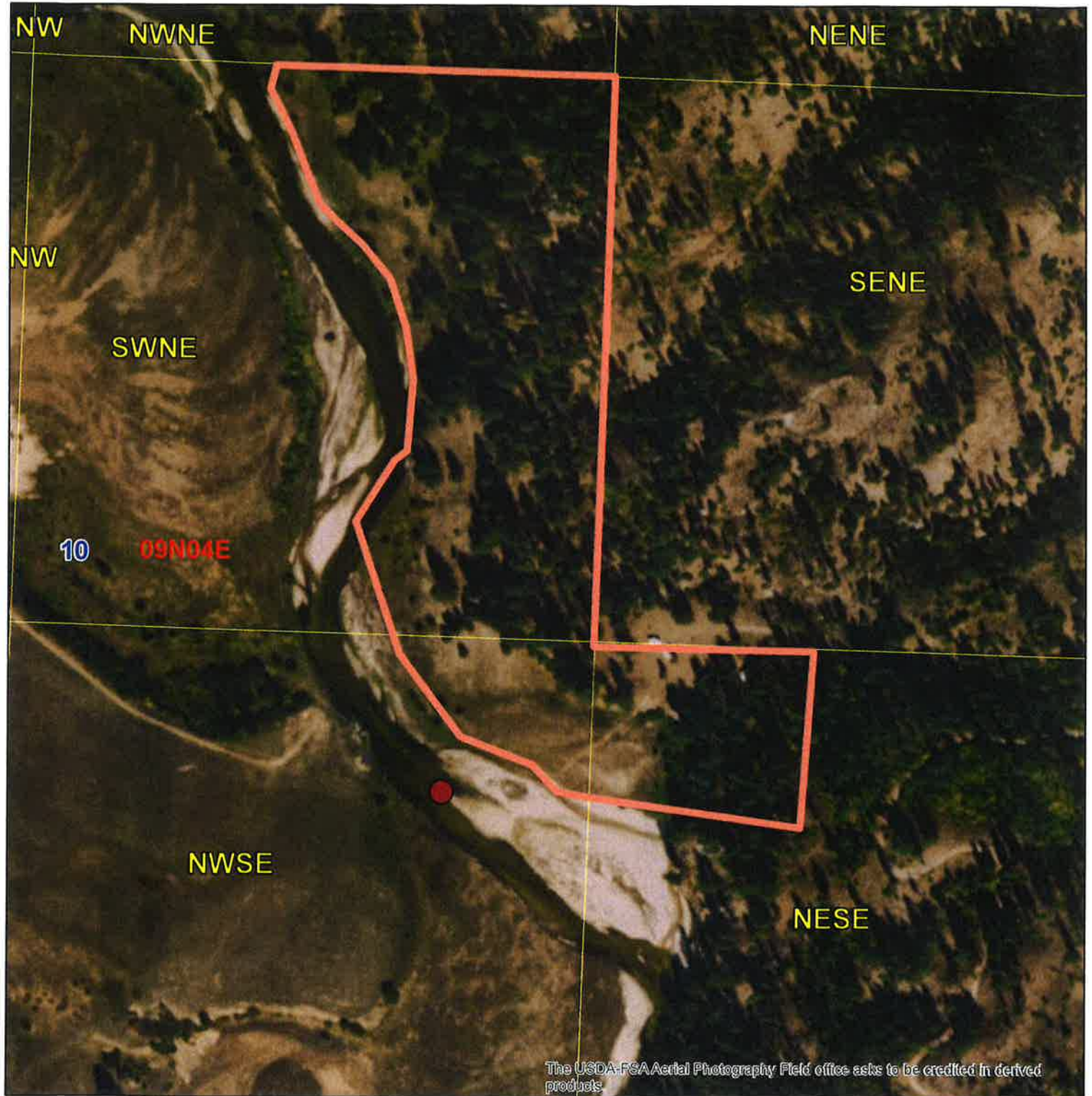

### Application for Permit & Transfer Withdrawal

Dear Rik and Margo Fraser,

The Department of Water Resources (Department) received your application for permit on July 20, 2020. I am currently working with Patrick to prepare your application for advertisement. Before we can advertise your permit application, you must address the following two items:

- i. *Fee/Transfer Withdrawal:* The Department will apply part of the payment you submitted with your transfer application no. 83891 to your newly submitted permit application. Before we can re-allocate your payment, you must officially withdraw your transfer application.

With this letter, I enclosed a blank withdrawal of application for transfer form. Once we receive your completed withdrawal of application for transfer, the Department will apply the necessary portion of your transfer 83891 fee to your new application and refund you the remaining amount.

- ii. *Map:* The Department requires you to submit a map with your application showing the POD and POU of your proposed water right. With this letter, I enclosed a map showing where I believe you intend to divert and use water based on our meetings. If the enclosed map accurately reflects your intended POU and POD, let me know via telephone, email, or letter and I will add this map to your application.
