 - 5. The department may cancel this approval at any time if the department identifies injury to other water rights.



REFERENCE: APPLICATION FOR TEMPORARY APPROVAL OF TWO WATER RIGHT APPROPRIATIONS

IDFG has reviewed your draft application for a temporary appropriation of water from Newsome Creek and from Tipi Creek for mining. You propose to withdraw water using gravity feed through a 34 inch pipe. You have asked to withdraw up to 1.0 gpm, the total volume not to exceed 0.003 AF. You indicate that you wish to withdraw water sporadically between May 15 and November 30, 2009.

Both Newsome Creek and Tipi Creek are closed to mining to protect resources. However, you indicated in a phone conversation that you do not intend to mine in either creek; rather, you will be using the water to wash remnant mine spoils away from the streams.

Based on the size of the proposed withdrawal and the duration of the activity, IDFG does not anticipate that the proposed withdrawals will have an adverse effect on fish, wildlife or stream habitat. We have no objection to the proposed withdrawals as long as all other required state and federal permits are secured for the proposed activity.

Please note that water intakes must be screened to prevent entrainment or impingement of fish. The maximum screen mesh size should be 0.25 inches; approach velocities should not exceed 0.5 ft/second to prevent losses of juvenile fish.

RE: Comments, temporary water appropriation from Tipi Creek and Newsome Creek for mining

Dear Mr. Thomas:

We received a copy of your application to the Idaho Department of Water Resources for a temporary water appropriation permit to withdraw 1.0 gallon per minute, maximum daily volume 0.003 acre feet from May 15th through Nov. 30th from Tipi Creek and Newsome Creek, Idaho County, for mining with a ³⁄₄ ABS pipe through gravity feed. Assuming all federal, state and local permits have been obtained, regulations met, and reviews completed, we offer the following comments.

In the Idaho Water Quality Standards, Newsome Creek is included in waterbody ID 17060305CL062 and is protected for cold water aquatic life and secondary contact recreation presumed beneficial uses. This waterbody ID is listed in section 4a of the Idaho 2008 Integrated Report and has a Total Maximum Daily Load allocation for temperature pollutants.

DEQ agrees that the temporary withdrawal of 1.0 gpm of water from Newsome Creek should not impact water quality. Flow data for Tipi Creek however, is not included with the request for comment; therefore, DEQ cannot determine if removal of 1.0 gpm will impact existing aquatic life beneficial uses in Tipi Creek. In order to protect and maintain aquatic life beneficial uses, stream flow adequate to sustain existing aquatic life needs to be maintained (IDAPA 58.01.02.100.01). We recommend that stream flow be maintained at a level suitable to protect and maintain aquatic life during the withdrawal and at no time should the stream be allowed to go dry as a result of legally appropriated and allowable water withdrawals. No waste water will be deposited back into Tipi Creek or Newsome Creek.

Dear Mr. Thomas:

The Idaho Department of Water Resources (IDWR) is in receipt of your two applications to temporarily appropriate water, for a small mining operation, on Newsome and Tippi Creeks. Before processing can begin, IDWR will need the following additional information;

Newsome and Tippi Creeks are located within the Salmon-Clearwater River Basins, which are now considered sensitive water basins. Each application within this sensitive area must undergo close scrutiny to ensure IDWR is not negatively impacting sensitive ESA (Endangered Species Act) species.

IDWR has developed a process by which each application is reviewed. Idaho State Code requires "approval is in the public interest and a determination that the temporary approval will not injure the public values associated with the water source or any other water right". Therefore, the applicant must obtain comments regarding their proposal from the Idaho Department of Fish & Game and the Idaho Department of Environmental Quality (DEQ), to make sure the proposed use will not harm sensitive species or public values.

Attached is an information sheet which explains the process. For a temporary water appropriation application, you are only required to seek comments from Fish & Game and DEQ. I have highlighted the contacts on page one for your convenience. When the applicant provides this information to the IDWR, the northern regional staff will continue with the processing of the application.

Please provide IDWR with the agency comments and a USGS map showing the location of the point of diversions and place of use within the next 30 days, so as not to delay processing. If you have any questions, feel free to contact me at this office.
