The protestant must also send a copy of the protest to the applicant.

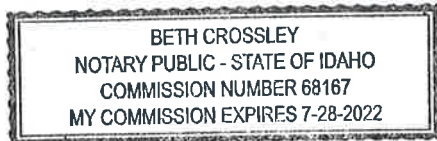

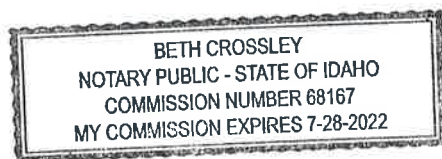
