Subject: Place of Use Change - Lezamiz

Greg,

I was just reviewing some aerial photos in the Big Lost River drainage and noticed an issue with the place of use for water rights 34-230, 34-231, etc. held by John Lezamiz Family Ltd. Partnership. Attached is a map with 2019 aerial photos showing the current POU shape for the water rights. There also appears to be more acres irrigated in the SENE of Section 31 than is reflected by the POU shape.

I know you've helped the Lezamiz family with water rights work in the past, so I thought I would start with you. It appears the small pivot in the NENE of Section 31, T07N, R25E is irrigating more than is currently reflected by the place of use shape. It appears there are other acres that are not being irrigated that could be shifted to cover the acres in the NENE. For example, the half pivot in Section 30 is smaller than what is shown on the water rights.

Lezamiz created a permissible place of use for these rights, so a transfer application might not be needed. Can you work with Lezamiz to prepare an updated place of use map? Thanks.



