- 1. T07 The right holder shall accomplish the change authorized by this transfer within one year of the date of this approval.
- 2. To Failure of the right holder to comply with the conditions of this transfer is cause for the Director to rescind approval of the transfer.
- 3. R05 Use of water under this right will be regulated by a watermaster with responsibility for the distribution of water among appropriators within a water district. At the time of this approval, this water right is within State Water District No. 63.

- 4. X27 This right is limited to the irrigation of 0.3 acres within the authorized place of use in a single irrigation season.
- The right holder shall make full beneficial use of all surface water rights available to the right holder for irrigation of the lands authorized to be irrigated under this right. The right holder shall limit the diversion of ground water under this right for land with an appurtenant surface water right(s) to those times when the surface water supply is not available or the surface water supply is not reasonably sufficient to irrigate the place of use authorized under this right.
- 6. 261 If the surface water right(s) appurtenant to the place of use is abandoned, forfeited, sold, transferred, leased or used on any other place of use, this right to divert ground water shall not be used on the land with an appurtenant surface water right(s) without an approved transfer pursuant to Section 42-222, Idaho Code, or approval of the Department if a transfer is not required.
- 7. WB7 This right when combined with all other rights shall provide no more than 0.02 cfs per acre nor exceed a combined annual maximum diversion volume of 38.07 af at the field headgate for the place of use.
- 8. X61 The period of use for the irrigation described in this approval may be extended to a beginning date of 3/1 provided that beneficial use of the water can be shown and other elements of the right are not exceeded. The use of water before 3/15 is subordinate to all water rights having no subordinated early or late irrigation use and a priority date earlier than 2/6/2007.
- 9. Rights 63-9937, 63-11343, 63-33817, 63-33819, 63-33821, 63-33823, 63-33825, 63-33827, 63-33829 and 63-33831 when combined shall not exceed a total diversion rate of 0.24 cfs, a total annual maximum diversion volume of 37.07 af at the field headgate, and the irrigation of 8.1 acres in a single irrigation season.
- 10. Rights 63-33821, 63-33825, 63-33827 and 63-33831 when combined shall not exceed a total diversion rate of 0.05 cfs, a total annual maximum diversion volume of 10.5 af at the field headgate, and the irrigation of 2.37 acres in a single irrigation season.
