This application proposes the diver-  
sion and use of water from Panther  
Creek tributary of the Salmon Wild &  
Scenic River. The decreed minimum  
stream flow rights for the federal Wild &  
Scenic Rivers are subordinate to cer-  
tain categories of water use and to spe-  
cific amounts of water use established  
after the minimum stream flow. The  
water use proposed in this application  
will benefit from the subordination pro-  
vision because the diversion rate 0.06  
cfs will be applied to the subordination  
amounts specified in the decree for the  
Wild & Scenic River listed above.
