This document is being prepared to satisfy the stipulated agreement dated December 1, 2014 signed agreement between SWC, Idaho Power, IGWA and Lance Funk pertaining to the approval of water right permits 35-14240, 35-14241, 35-14242 and 35-14243. The stipulated agreement states that a written report by a qualified consultant will verify the actual acres irrigated during the current irrigation season by August 15 of each year.

It is necessary to note that water right transfers 83782 and 83781 were approved by IDWR on April 16, 2020. The transfer shifted 46.7 acres of the allowed irrigated acres around with some of the more senior water rights on the farm. No additional acres were transferred into the farm. No acres were transferred off of the farm. Water right license 35-14655 was split off of water right license 35-14240.

Water right license 35-14240 is irrigating 122 acres during the 2020 irrigation season. A site inspection was performed on June 26, 2020. The flowmeter for this water right were inspected and appear to be working correctly.

Water right license 35-14655 is irrigating 46.7 acres during the 2020 irrigation season. A site inspection was performed on June 26, 2020. The flowmeter for this water right were inspected and appear to be working correctly.

Water right license 35-14241 is irrigating 369.1 acres during the 2020 irrigation season. A site inspection was performed on June 26, 2020. The flowmeter for this water right were inspected and appear to be working correctly.

Water right permit 35-14242 is irrigating 119.5 acres during the 2020 irrigation season. A site inspection was performed on June 26, 2020. The flowmeter for this water right were inspected and appear to be working correctly.

Water right permit 35-14243 is irrigating 659.0 acres during the 2020 irrigation season. A site inspection was performed on June 26, 2020. The flowmeters for this water right were inspected and appear to be working correctly.






