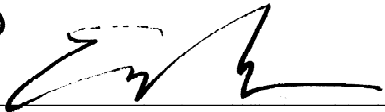
On July 2, 2020, the Respondent filed a *Motion* seeking to extend the deadline to lodge the agency record and transcript with the Idaho Department of Water Resources (“Department”) from July 7, 2020, to July 21, 2020. It also seeks to extend the deadline to lodge the settled agency record and transcript with the district court from August 4, 2020, to August 18, 2020. Last, the *Motion* seeks to reschedule the oral argument in this matter from November 19, 2020, to December 3, 2020, at 1:30 p.m. (Mountain Time). Counsel for the Respondent represents that counsel for the Petitioner and Cross-Petitioner does not oppose the *Motion*. Given the *Motion* is unopposed, the Court in an exercise of its discretion will grant the *Motion*.

THEREFORE, BASED ON THE FOREGOING, THE FOLLOWING ARE HEREBY ORDERED:

1. The Respondent's *Motion for Extension* is hereby granted.
2. The agency record and transcript shall be lodged with the Department on or before July 21, 2020.
3. The settled agency record and transcript shall be lodged with the district court on or before August 18, 2020.
4. Oral argument in this matter will be reset to be heard **December 3, 2020, at 1:30 p.m. (Mountain Time)** at the Snake River Basin adjudication District Court, 253 3rd Avenue North, Twin Falls, Idaho. Oral argument will be conducted via Zoom with instructions to be provided to the parties at a later date. The form and order of argument shall be governed by I.A.R. 37.
