On May 14, 2020, the hearing officer issued a *Notice of Hearing, Scheduling Order, and Request for Argument Briefs*, scheduling these consolidated cases for an administrative hearing to begin on August 27, 2020 at 9:00 am. On August 7, 2020, the Applicant's attorney, Rob Harris, notified the hearing officer that the parties were working on a potential settlement of the contested case and wanted the hearing and its associated deadlines cancelled to allow time for further settlement discussions. The Applicant's attorney also asked that a status conference be scheduled in place of the hearing to discuss rescheduling the hearing and disclosure deadlines, if necessary.

ORDER

IT IS HEREBY ORDERED that the administrative hearing scheduled for August 27 and 28, 2020 is CANCELLED and the disclosure deadlines that have not already passed are VACATED. The hearing will be rescheduled at a later date if the parties are unable to reach a settlement in the contested case.
