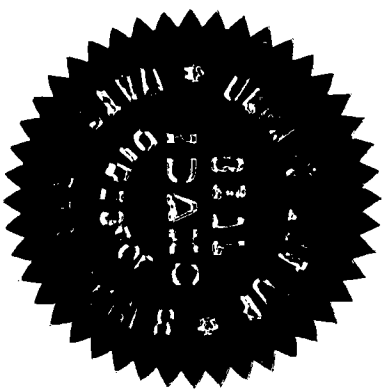

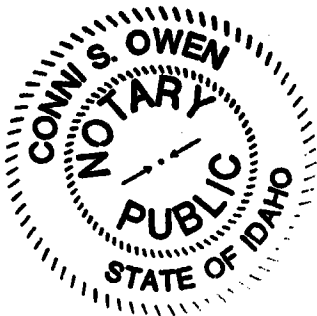
OFFICIAL OATH
