**ORDER AUTHORIZING DISCOVERY**

During the July 30, 2020 status conference, the parties asked the presiding officer to set a schedule for written discovery requests prior to setting deadlines for dispositive motions or a hearing date. Pursuant to Rules 413(b), 520 and 521 of the Department's Rules of Procedure (IDAPA 37.01.01), the parties may engage in discovery as follows:

1. General discovery may begin immediately.
2. Parties may use email service for discovery requests and responses.
3. Discovery requests shall be served by the requesting party on or before October 6, 2020.

4. Discovery responses shall be served on the requesting party within 30 days of the discovery request.

5. Discovery shall be completed by November 6, 2020.


