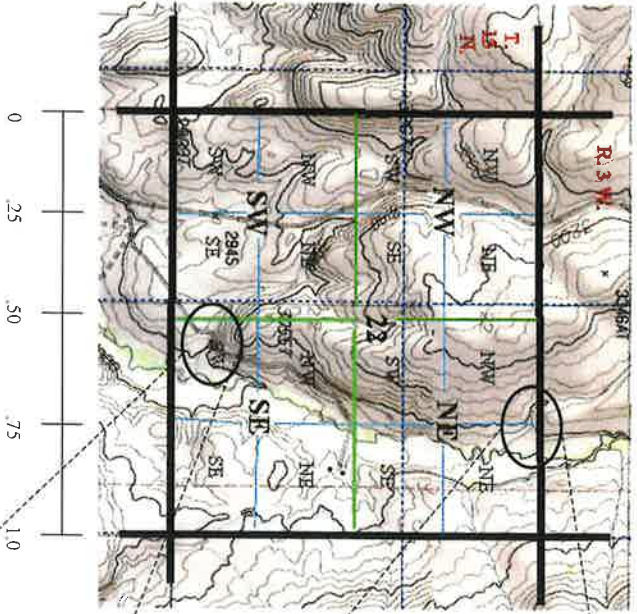

Spring snowmelt water from surface drainages known as Kohlhepp draw & Edward's draw will be used to nurture and grow evergreen trees for future lumber harvest. Snow will be diverted from surface drainages in spring into four 500 gallon storage tanks. From there, solar pumps will deliver the water to the trees being grown. Storage tanks will remain full enough until late in the season to get the trees through the hot summer months.

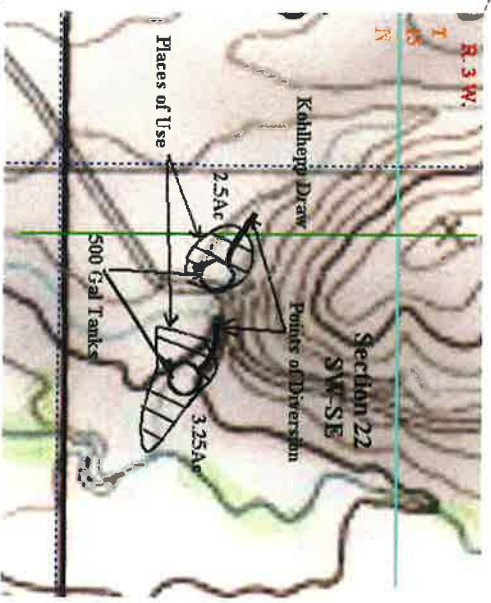
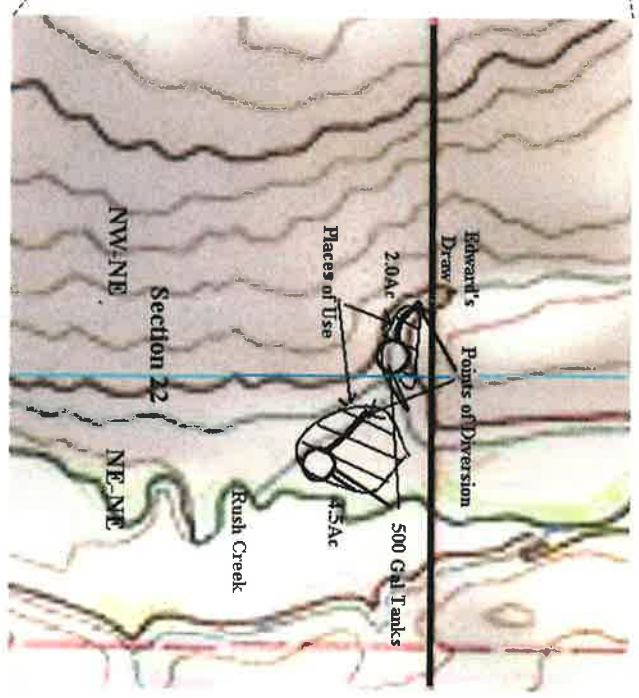

On 6/22/2020, the Department of Water Resource (Department) received an application for permit in the name of Paul & Gayle Poorman. The application proposed diverting 0.20 cfs divided equally between four points of diversion (POD). Each POD will deliver irrigation water to a distinct place of use (POU) totaling 12.25 acres of irrigated land. The Department decided to process Poorman's filing as four separate applications- each describing one of the four proposed irrigation areas.

The filed application was separated into four applications as follows:

Dear Applicant:

On 6/22/2020 the Department of Water Resources (Department) received your application for permit for irrigation uses. Based on the nature of your proposal, the Department has decided to split your application into four separate water right applications- one application describing each of your four irrigation locations.

You filed application for new water rights from a regulated source within the Weiser River Water District. Regulated sources include tributary surface water and tributary shallow ground water (ground water above the first confining layer in the aquifer). If approved, your application would be a junior water right.

The Weiser River watermaster regularly curtails junior water rights by June 15 each year. This is necessary under Idaho law to protect senior water rights when the water supply is not adequate to fill all rights at the same time.

This means your application, if approved, would include a condition of approval automatically curtailing your new use by June 15 of each year. This condition of approval balances protection of senior water rights with promotion of the maximum economic benefit of water resources.

To determine if you want to proceed with your application based on the above explanation, please complete and return the enclosed questionnaire. Your written reply must be received within the next thirty (30) days. Failure to make a timely response will cause your application to be voided. A refund of the application fee cannot be issued for a voided application.
