Friends of the Teton River does hereby protest the above referenced application for transfer on the basis that approval of the transfer, as currently proposed, will impact or injure Friends of the Teton River and other water users in the watershed.

Specifically, surface water and groundwater in the Teton River watershed are highly interconnected. The watershed is over appropriated, with surface water rights subject to curtailment on an annual basis and groundwater supply declining. As such, any groundwater withdrawals, even those relatively small in nature, when moved in the manner proposed in the transfer application, will impact the quantity of water available to other water rights in the new place of use.

The proposed transfer seeks to move water in an unprecedented manner in Basin 22, from a downgradient location on the west side of the Teton River to an upgradient location on the east side of the Teton River, approximately 10 miles in distance. Groundwater withdrawal at the proposed new point of diversion will, necessarily, decrease historic water availability in the Moose Creek/Trail Creek drainage thereby decreasing water availability for senior and junior water rights – both surface water rights and ground water rights – in that area. Drying of the historic place of use associated with the water right will not address the localized depletions and decreased water availability in the Moose Creek/Trail Creek drainage. As such, the transfer, as proposed, will result in injury.
