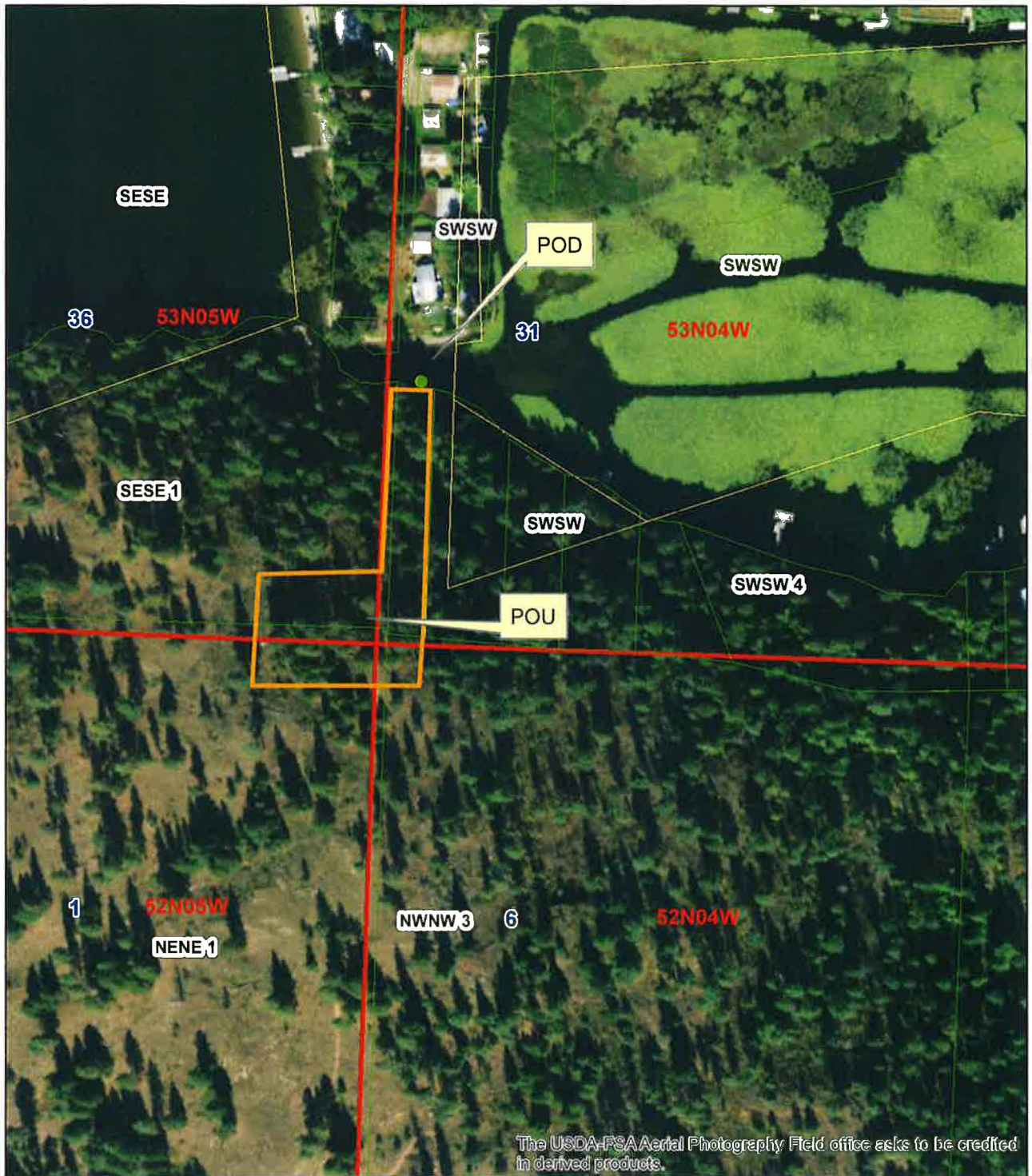

Re: Application for Water Permit and associated Government Lot Designation

An application for permit was received for domestic use in the name of Randy Uchytel. During application processing, IDWR staff identified that while the applicant had designated a $\frac{1}{4}$ $\frac{1}{4}$ location of SWSW for the place of use (POU), the government lot designator GL4 was not added in the description. POU data entry was adapted to include the government lot designator and will read SWSW4.

Additionally, applicant had assigned the point of diversion (POD) location as SWSW, but applicant map shows the POD in the SWSW4. POD data entry was adapted to add the government lot designator (4) to POD during application processing and shall read SWSW4.
