CONDITIONS OF APPROVAL AND REMARKS

1. This water right is appurtenant to the described place of use.
2. This right is subject to all prior water rights and may be forfeited by five years of non-use.
3. Modifications to or variance from this license must be made within the limits of Section 42-222, Idaho Code, or the applicable Idaho law.
4. Right 43-02335 is also diverted through the point(s) of diversion described above.
5. The right holder shall use the full allotment of appurtenant surface water rights in conjunction with groundwater diverted under this right.

CONDITIONS OF APPROVAL AND REMARKS

6. This right to divert groundwater shall not be used if the surface water right(s) appurtenant to the place of use is sold, transferred, leased or used on any other place of use without the approval of the Department.
7. This right is limited to the irrigation of 255.9 acres within the place of use described above in a single irrigation season.
8. This right when combined with Right 43-02335 and all other rights shall provide no more than .02 cfs per acre nor more than 4.0 afa per acre for the lands above.
9. Use of this right with Right 43-02335 is limited to a total combined annual diversion volume of 1441.2 af and to the irrigation of a combined total of 360.3 acres in a single irrigation season.

This license is issued pursuant to the provisions of Section 42-219, Idaho Code. Witness the seal and signature of the Director, affixed at Boise, this 15th day of JANUARY, 19 96.
