Intro

On May 14, 2020 SPF Water Engineering (SPF) submitted 2019 Annual Water Level Monitoring Report (Monitoring Report) for the Dry Creek Ranch Aquifer Monitoring Plan for Permit 63-32423. Permit 63-32423 condition twelve (12) requires the right holder to carry out the "Dry Creek Ranch Aquifer Monitoring Plan: April 2008." (See Exhibit E of the January 14, 2009, Water Rights Agreement between Dry Creek Rural Neighborhood Association and JMM Dry Creek LLC.)

Report Review

Sixteen wells were visited during the Fall 2019 and spring 2020 monitoring events. At least one measurement was obtained from all 16 wells. At this time, there are no significant obstructions or other issues with obtaining water level measurements in any of the wells included in the monitoring program.

Measurements from seven of the ten original wells (excluding the Pasture Well, Graves Well, and Payne Well) plus nine off-site DCRNA wells will continue to be taken twice a year (April and October) until termination of the program, measurements are no longer physically possible, or a well is withdrawn from the program by the well Owner. In accordance with the Plan, monitoring will continue until at least 2025 (i.e., 15 years after permit approval).

Conclusions

The requirement for the permit holder to carry out the approved monitoring plan for permit 63-32423 have been satisfied.

Dear Leslie.

This letter summarizes the status of the Dry Creek Ranch Aquifer Monitoring Plan (Plan) dated April 2008.

Description of Monitoring Plan. The Plan was implemented by JMM Dry Creek (JMM) as part of a Water Rights Agreement (Agreement) between the Dry Creek Rural Neighborhood Association (DCRNA) and JMM Dry Creek (JMM). The Agreement, with an effective date of January 14, 2009, was established to resolve the DCRNA protest of JMM's Application for Permit 63-32423 and to avoid a possible protest of JMM's Application for Transfer 73817.

Note that JMM changed its name to P&F Dry Creek, LLC, in July 2014. Idaho Department of Water Resources changed the name on Permit 63-32423 on August 25, 2014. JMM subsequently assigned Permit 63-32423 to BHH Investors 1414 LLC on August 31, 2016. Monitoring is currently being conducted on behalf of BHH Investors 1414 LLC.

Monitoring Wells. Well locations are shown on Figure 1 in Appendix A.

The Plan originally included six wells located on the Dry Creek Ranch property and four off-site wells. The on-site wells were Well 9, Payne Well, Big Pump Well, Hot Well, Stockwater Well, and Pasture Well. The four off-site wells were the Beliveau Well, Thompson Well, Graves Well, and the Dater Well. Monitoring of these ten wells began in June 2007. Measurements were taken every two months through 2008, and then every 6 months thereafter. The most recent set of measurements were taken on April 24, 2020.

 Artesian pressure has not been measured from the Pasture Well since April 2010. The well head was leaking at this time, preventing an accurate measurement of pressure. The Pasture Well was abandoned by Post Drilling Inc. on December 8, 2016, and has been removed from the monitoring plan. A copy of the well abandonment report can be found in Appendix B.

- During Fall 2012 monitoring, SPF Water Engineering's (SPF) electric line well sounder became snagged somewhere along the drop pipe/power cable in the Graves Well. Any future monitoring at this well would require installation of a well sounding tube. Connie Graves declined SPF's offer to install a well sounding tube free of charge. As a result, the Graves Well has been removed from the monitoring plan.
- During Spring of 2015, the new homeowner of the Thompson Well requested that his well be removed from the monitoring program. In July 2018, the new homeowner (Joe Watterson) requested that his well be reinstated as a monitoring point. A signed monitoring agreement for the Watterson (formerly Thompson) well is included in Appendix C.
- The original Dater Well was monitored through April 2016. This was a shallow well with a static water level that fluctuated between 35 and 51 feet. Measurements in October 2016 and April 2017 encountered an obstruction above the water level at approximately 40 feet. A new, deeper well was drilled in 2013 which has been monitored in place of the shallow well since October 2016.
- Artesian pressure was measured at the Payne well through April 2013. Between April and October 2013, the artesian flow was redirected down a pipe with no hose bib so pressure measurements were no longer possible. The Payne Well was abandoned by Post Drilling Inc. on April 3, 2018 by filling it with cement and was observed to no longer be flowing during the April 10, 2018 monitoring event. A copy of the well abandonment report can be found in Appendix B. The Payne Well is no longer monitored.
- In July 2018, Leslie Nona requested that the irrigation and domestic supply wells on her property at 6411 W Dry Creek Road be added to the monitoring program. A signed monitoring agreement for both of the Nona wells is included in Appendix C.

The Agreement also required adding six off-site DCRNA wells to the Plan. Nine (9) DCRNA wells have been added so far. Three were added in April 2009 (Johnston, Podolan, Rishel), three more were added in April 2010 (Chapin, Golis, Hull), one was added in April 2016 (Jordan), and two were added in 2018 (Nona Irrigation, Nona Domestic). The wells added in 2009 and 2010 were measured every two months during their first year in the monitoring program, then every six months thereafter. The Jordan, Nona Irrigation, and Nona Domestic wells have been measured every six months since they were first added to the monitoring program. All of the named wells were most recently measured on April 24, 2020 and are included on Figure 1.

Monitoring Program Status. Measurements from seven of the ten original wells (excluding the Pasture Well, Graves Well, and Payne Well) plus nine off-site DCRNA wells will continue to be taken twice a year (April and October) until termination of the program, measurements are no longer physically possible, or a well is withdrawn from

the program by the well Owner. In accordance with the Plan, monitoring will continue until at least 2025 (i.e., 15 years after permit approval).

Fall 2019 and Spring 2020 Monitoring. Sixteen wells were visited during the Fall 2019 and Spring 2020 monitoring events. At least one measurement was obtained from all 16 wells. At this time, there are no significant obstructions or other issues with obtaining water level measurements in any of the wells included in the monitoring program.

Summary of Data. Water level measurements collected to date from 20 monitoring wells are presented in Table 1 in Appendix A. In order to more clearly present the collected data, the measurements are presented in three figures in Appendix A. Figure 2 shows data for wells with depth to water of 100 feet or less, Figure 3 shows data for wells with depth to water of greater than 100 feet, and Figure 4 shows pressure measurements at the artesian wells.






