

MEMORANDUM

Re: Temporary Water Use Application TP-63-341

Applicant: The Department received this application for temporary approval of water use on 7/8/2020 from Michael Sperry. The applicant proposes to divert water from Grimes Creek, tributary to the Boise River for mining activates using a highbanker. Water diversions are requested from July 8 to September 30, 2020. The place of use (POU) and point of diversion (POD) are both located NE of Pioneerville, ID. According to the application, the proposal will accomplish an intended objective of pumping water with a 2 inch hose.

The Department previously received a temporary approval of water use application from Mr. Sperry on 4/22/2020. The Department did not process this application as it was largely incomplete Furthermore, Mr. Sperry called the Department on 4/23 stating he wished to cancel the application due to EPA restrictions preventing him from highbanking in the area.. Therefore, no number was assigned to the application. The prior \$50 application fee will be applied from the first temporary approval to this temporary request on Grimes Creek.

This application proposing diversions from Grimes Creek was also incomplete. The PLSS description on the application for the POD was missing the Section information and the POU description was left blank. Furthermore, the application did not list a maximum volume over the duration of the request. Based on the application map, I was able to determine that the POD and POU are in the Government Lot 14 in the NENE QQ, the SENE QQ, the SWNE QQ and the NWSE QQ, all in Section 3, Township 7N and Range 5E. The map's depiction will be used as the as the basis for the POU and POD. I called and emailed Mr. Sperry on 7/9/2020 to discuss the missing information on the application. He returned my call on 7/13 and he authorized me to make the corrections on his behalf as well as to use the application map as the basis for the POU/POD locations.

The maximum volume over the duration of the request was determined by taking the maximum daily volume of 21,000 cfs and multiplying it by 70 days (70 days was determined from diversions occurring every day from July 24-September 30th). The outcome is approximately 1,470,000 gallons or 4.5 AF.

Proper Administration: The proposal is within Water District 63. Watermaster Rex Barrie or assistant Watermaster Mike Meyers could administer the use if necessary.

Public Interest: Based on the information available, the proposal is within the public's interest.

Injury to Public Values: Based on the information available, the proposal does not appear to cause injury to public values. On 7/9/2020, comments were requested from the IDFG, DEQ and BLM. No comments reading the application have been received from the IDFG or DEQ as of the date of this memo, so it is assumed there are no concerns. The BLM submitted comments on 7/22 requesting that the applicant install a fish screen at the diversion intake. Additionally, the BLM requested the applicant notify the Four Rivers Field Office of the BLM to assess if a Notice of Intent of Plan of Operations is necessary for the proposed activities on Grimes Creek.

Other Sources of Water: Based on the POD/POU location, there are no other sources of water. It is reasonable for the applicant to request diversion from Grimes Creek as it appears to be the only source of water flowing though the proposed area.

Injury to Existing Water Rights: Approximately 0.3 miles below the proposed area of diversion, BLM water right 63-29086 authorizes the diversion of 0.02 cfs from Grimes Creek for stockwater use. The POU for this right also overlaps the proposed POU for this temporary approval. No injury is anticipated to this right due to the low diversion rate and dispersed area of use. Below 63-29086, the next water right authorizing diversion from Grimes Creek is 63-29343, for stockwater and wildlife use by the BLM. This right is approximately 4 miles downstream. Due to the distance between the POD for 63-29086 and the diversion locations under this temporary approval, no injury is anticipated to 63-29086.

2020 temporary approvals 63-321 and 63-322 also authorize diversions from Grimes Creek within the same reach requested by this temporary approval. 63-321 authorizes 0.06 (25GPM) cfs and a total of 5 AF to be diverted from April 1st through November 1st 2020. 63-322 also grants the diversion of 0.06 and 5 AF but from both Grimes Creek and nearby Big Muddy Creek to the west. This temporary approval is authorized to divert water from May 1, 2020 to May 1, 2021.

The mining use proposed by this temporary approval will presumably be non-consumptive and should not cause injury to the water rights mentioned above or other rights below the POD. Injury to other water rights is not anticipated.

The application proposes diverting 70 gpm, maximum daily volume of 21,000 gallons and 1,470,000 gallons over the duration of the request. 1,470,000 gallons equates to 4.5AF which is within the 5.0 AF maximum allowed.

Department Staff and Watermaster Comments: Comments were submitted to Nick Miller at Western Region and to watermasters Rex Barrie and Mike Meyers of Water District # 63 on 7/9/2020. Mike responded on 7/10/2020 with the requirement that the applicant rent water from WD # 63 rental pool.

Western responded on 7/13 suggesting to solicit comments from the Baumhoff's, who are a family owning large tracts of land along Grimes Creek. In the past, they have experienced issues with trespassing relating to small scale mining activities from Grimes Creek. It is good practice to notify them of proposed diversions from Grimes Creek and the surrounding tributaries. Although Nick did not anticipate this temporary approval encroaching on their land, he suggested to notify them of the

All, after review of the application, we have the following comments:

From our fisheries biologist:

Grimes Creek is categorized by IDEQ 4A (not supporting beneficial uses due to temperature) and 4C (not supporting due to physical substrate habitat alterations). Grimes Creek is redband trout habitat, so a filter/screen needs to be in place to prevent capture of fish in the piping of water from the creek. (This is usually a condition on the IDWR permit).

From geologist:

There are five active Notices/Plans on BLM land in T. 7N., R. 5E, Sec. 3, but this application is not for one of those five. If approved, it should be mentioned to the applicant they need to Notify the BLM Four Rivers Field Office to see if they need to file a Notice of Intent or a Plan of Operations. Use of high bankers often does not fit in the casual use category, so we would need to know what they are doing in order to determine their appropriate level of use.

The Department of Water Resources received your temporary approval of water use application yesterday. Upon initial review, there is some missing information and clarification is needed on other items as well.

I attempted to call you this afternoon and left you a voice message. The incomplete items on the application are:

- Item 2- Location of point(s) of diversion. This area is incomplete as the Section is not listed on the Public Land Survey System (PLSS) description. However, based on the map you included with the application, the points of diversion are in the following PLSS locations:
 - Govt. Lot 14 in the NENE quarter-quarter of Section 3, Township 7 North, Range 5 East.
 - SENE quarter-quarter of Section 3, Township 7 North, Range 5 East.
 - o SWNE quarter-quarter of Section 3, Township 7 North, Range 5 East
 - o NWSE quarter-quarter of Section 3, Township 7 North, Range 5 East
- Item 3- location of place of use. This section is completely blank on the application. The Department cannot issue a temporary approval if we do not know where the water will be used. Again, based on the map provided with the application, the place of use is in the following PLSS locations (which are the same as the point of diversion PLSS descriptions above):
 - Govt. Lot 14 in the NENE quarter-quarter of Section 3, Township 7 North, Range 5 East.
 - SENE quarter-guarter of Section 3, Township 7 North, Range 5 East.

So, 21,000 gallons per day (70 gallons per minute X 60 minutes=4,200 gallons per hour X 5 hours= 21,000 gallons daily) multiplied by the maximum diversion of 70 gallons per minute is approximately 1,470,000 gallons or 4.5 AF over the duration of the request.
