Your application for Temporary Approval of Water Appropriation has been granted.

Please be advised, this permit is subject to the effective dates and conditions stated on page 2 of the application. Water sufficiency for senior water rights along with associated public values must be protected during summer-fall low flows. Elk Creek is the primary water source for Idaho City. Therefore the approval expires on **August 1, 2016** and allows for a **maximum diversion of 5 AF and a maximum rate of diversion of 0.56 CFS.**

Also, note the condition requiring the **purchase of storage water from the Boise River Rental pool** to mitigate injury to downstream water right holders below Lucky Peak.
