NOTICE OF HEARING

On April 16, 2020, Nova Jones, LLC filed Application for Permit No. 11-7863 with the Idaho Department of Water Resources ("Department"). The application was protested by PacifiCorp and Bear Lake Watch, Inc. The department conducted a prehearing conference on July 21, 2020. During the conference, the parties requested that an administrative hearing be held to resolve the protested matter.

The department has scheduled the matter for a hearing beginning at 9:00 a.m. on October 20, 2020 at the Oregon Trail Center, located at 320 N 4th St. in Montpelier, Idaho.

The hearing officer for the department will be James Cefalo, whose mailing address is 900 N Skyline Dr., Suite A, Idaho Falls, ID 83402 and whose email address is james.cefalo@idwr.idaho.gov.

The hearing will be held in accordance with the provisions of Chapters 2 and 17, Title 42 and Chapter 52, Title 67, Idaho Code, and the adopted Rules of Procedure of the department, IDAPA 37.01.01. Copies of the code/rules are obtained from the department's website, www.idwr.idaho.gov, or upon request.

All parties appearing in the matter will have the opportunity to present information, examine witnesses, and provide argument on issues related to the contested application.

The hearing will be conducted in a facility that satisfies the accessibility requirements of the Americans with Disabilities Act. If you require special accommodations in order to attend, participate in, or understand the conference, please notify the department at least (10) days prior to the hearing. SCHEDULING ORDER

- 1. General discovery shall begin immediately. Discovery requests are limited to interrogatories, requests for documents, and depositions. Responses shall be served on the requesting parties within 30 days of the request. Written discovery requests shall be served on or before August 21, 2020. General discovery will close on September 25, 2020.
- 2. Expert reports shall be served on opposing parties and the hearing officer on or before September 4, 2020. Rebuttal reports, if prepared, shall be served on opposing parties and the hearing officer on or before September 18, 2020.
- 3. On or before October 9, 2020, each party must disclose to all other parties and the hearing officer the identity of all witnesses that may testify for the party at the hearing.
- 4. On or before October 9, 2020, each party seeking to offer exhibits at the hearing must serve on all other parties and the hearing officer copies of the proposed exhibits. Service of the proposed exhibits will satisfy Rule 606 of the Rules of Procedure. To avoid duplication of exhibit numbers, Applicant shall use exhibit numbers 1-100. Protestant PacifiCorp shall use exhibit numbers 101-200. Protestant Bear Lake Watch shall use exhibit number 201-300.
