WATER SUPPLY BANK

Dear Mr. Christensen:

The department has reviewed the above referenced applications which you submitted to the department on November 18, 1999. The review shows that License No. 45-07008 has an authorized place of use of 238 acres located in the NW1/4 and NW1/4SE1/4 Section 33, T10S, R22E, B.M. The Snake River Basin Adjudication claim which was submitted based on this license claims a the irrigation of 274 acres located in the W1/2SW1/4 section 28 and NW/14, NE1/4SW1/4 and NW1/4SE1/4 Section 33, all in T10S, R22E, B.M.

Please consider that the water rights offered for lease have been accepted into the bank and will be retained in the bank through December 31, 2000. Several items to keep in mind in connection with the lease are as follows:

1. The monetary return to the owner of a right for rental of the rights from the bank is \$2.25 per acre foot of water per year.
2. There is no payment to the owner if the rights are not rented from the bank.
3. While in the bank, the water rights may not be used by the owner, even if the rights are not rented from the bank.
4. A right leased to the bank will remain in the bank until it is released by the Water Resource Board or until December 31, 2000 whichever is earlier.
5. While a water right is in the bank, forfeiture provisions are stayed. The five (5) year period of non-use for forfeiture of a water right shall begin to accrue upon removal of the right from the bank if a period of non-use did not occur prior to the effective date of lease and will continue to accrue if a period of non-use occurred prior to the right being leased to the bank.

6. Receipt of the rights into the bank does not confirm that the changed place of use claimed in the Snake River Basin Adjudication for License No. 45-07008 is valid or will be decreed in the SRBA as claimed.
